### PRIMARY OBJECTIVE OF POSITION:

Performs semi-skilled work in the operation of equipment for the purpose of parks, cemetery, green waste facility, wastewater treatment plant, airport, and property maintenance. Operates small mowers or other maintenance machinery; performs heavy labor such as shoveling, raking, etc.; hoes, plants and otherwise beautifies flower beds and plantings; may act in a self-supervising capacity; may supervise other laborers in maintenance projects; operates large riding mowers and similar maintenance equipment.

### MAJOR AREA OF ACCOUNTABILITY AND PERFORMANCE:

1. Works to maintain and beautify City parks, cemetery, and property.
2. Operates small mowers or other maintenance machinery.
3. Performs heavy labor, such as shoveling, raking, etc.
4. Hoes, plants, and otherwise beautifies flower beds and plantings.
5. May act in a self-supervising capacity.
6. Operates large riding mowers and similar maintenance equipment.

### EDUCATION, TRAINING AND EXPERIENCE REQUIREMENTS:

Physical ability to accomplish heavy labor for long periods; experience in outdoor maintenance work; experience in or ability to operate large riding mowers, etc.

### ESSENTIAL JOB FUNCTIONS:

Operates and maintains a variety of mowing and trimming equipment for park, cemetery green waste facility, wastewater treatment plant, and airport and property maintenance.

### OTHER INFORMATION:

1. Must be 18 years of age or older.
2. Must possess valid state of Utah driver license.
3. Period of employment is three to six months.
4. Safety shoes required when working around or operating all mowers and machinery; supplied by employee.
5. Required to work holidays and weekends as scheduled; must be available from 5:00 a.m. to 11:00 p.m. as scheduled.
