#### **ITEM 1: CALL TO ORDER**

Mayor Jeppsen welcomed everyone and called the City Council meeting to order.

#### **ITEM 3: PRESENTATION**

### A. Box Elder Family Support Center

Jill Scharrenberg, Acting Director of Box Elder Family Support Center said they have been in the community for 29 years and they were at the meeting to ask for support and funding (from Perry City). She said Danielle (Gardner), who was a Perry City resident and used the facility, will speak on the impact the Support Center has on families. Ms. Scharrenberg explained what the Support Center does to help the people in the community who might be in crisis and need help. She gave a few examples of the children they have helped.

Ms. Gardner read a note written by her daughter about the help their family had received from the Box Elder Family Support Center. Ms. Gardner's other daughter spoke of the time when she and her sister were being cared for at the Support Center and how happy and safe, they felt when they were there. Ms. Scharrenberg gave a proclamation to improve the quality of life for children and families and ask for funds from Perry City.

Council Member Walker asked Ms. Scharrenberg if she knew how many people per year use this service. Ms. Scharrenberg responded that last year they had 2000 hours (of service) and helped 200 families. She added that they were receiving many coat donations and then she gave examples of families that will use this service. Ms. Scharrenberg asked them to sign a proclamation to offer

funds and Mr. Morris said that this was not on the agenda to execute a proclamation. Ms. Johnson said the request to ask for support will be put on the January agenda then asked for the amount the Support Center wanted. Ms. Scharrenberg responded that anything would help.

Council Member Tueller asked what it takes to fund their organization on a yearly basis. Ms. Scharrenberg responded that they would get two grants but (recently) lost funding on the one and the other grant was from Utah Division of Child and Family Services (DCFS). Council Member Wright asked why they lost the grant and how much funding it gave. Ms. Scharrenberg responded that they lost \$217,000 and the grant was lost because of the difference of opinion on the operation of the facility. Mr. Morris said he was familiar with Your Community Connection (YCC) Family Crisis Center in Weber County where they figure what they are short and divide it between the city and the county and then ask for that amount of money from each. Chief Hancey commented that Box Elder Family Support Center provides great service to Perry City. Mr. Morris counseled the council members to be careful with donations because it must comply with the corporate purpose section.

# B. Resolution 2023-24 Fiscal Year 2024 Budget Amendment

Ms. Johnson said this budget amendment was to add money to the building grounds and maintenance budget for the artwork that was proposed to them. She explained that the funds are coming from available cash which is at 22% and that the \$4,000 will not impact the fund. She reminded the council that Garry Case presented a discount on his service to paint a picture for the new City Hall lobby.

Mayor Jeppsen changed and started with Action Item H. With the decision made on Action Item H the Mayor made a motion to table this resolution. Council Member Tueller asked the council if their choice was because of the selected picture or the cost of the artwork or both. Mr. Morris counseled the council members about what they could do with the incomplete motion on this proposal.

## B. Ordinance 23-N Zoning Map Amendment

Ms. Johnson said this amendment comes from a zone change application submitted by Irv Maddox. The location for this proposal was 1900 S Highway 89 and Mr. Maddox wanted the zone changed from Agricultural (A) to Neighborhood Commercial (NC) in order to expand his bike shop. Ms. Johnson showed a map of the area and explained the surrounding zones and uses.

Council Member Wright was concerned about the buffalo in the lot behind the shop and if this zone change will cause compliance issues. Mr. Morris said the buffalo are pre-existing and as long as they continue to keep them there it will be allowed (grandfathered). Council Member Ostler asked if there were any public comments in the public hearing. Ms. Johnson called Ms. Tyra Bischoff, the Planning Commission Secretary, and she said there were comments of concerns about increased traffic and congestion in the area. The council continued to review and discuss the map and overview of the city grid for potential land uses that will be available with this zone change.

#### G. Approval of the Fiscal Year 2023-2024 Impact Fee Plan

Ms. Johnson said this needed to be approved before the end of the year because it will need to be submitted with our audit (paperwork). She explained this was done each year and they (had already) looked at what was available with impact fees at the end of June (the end of the fiscal year 2023). She said she and the City Administrator, Public Works Director, and City Engineer had a meeting to discuss the best use of these impact fees. She highlighted a few of the projects they planned in the next couple of fiscal years and other uses of this fund (see Impact Fee Schedule). She highlighted that these funds would go towards park improvements, a water well with a tank, and storm drainage repair or replacement.

## H. Motion Regarding Garry Case Art Proposal

Mayor Jeppsen said they will discuss this motion before the Resolution 2023-24 Fiscal Year 2024 Budget Amendment. Council Member Walker referred to the email he sent (see copy of email in packet) and then explained that Mr. Case wanted to contribute his talents to the city. He showed the picture Mr. Case wanted to base his painting on (a picture of white rock on the east bench of Willard) and that he had already started to paint it. Council Member Walker noted that he reminded Mr. Case that the city had not commissioned him yet and Mr. Case acknowledged that he would use it for something else if the city did not want it. Council Member Walker highlighted that commissioning another artist would cost the city a lot more than the \$4,000 presented.

Council Member Wright asked if Mr. Case presented another (picture) option and Council Member Walker responded that this was what Mr. Case thought would be best. Some concerns were expressed that the proposed picture was located in Willard City, not Perry. Council Member Young asked if there were any prints that might be enlarged and hung. Council Member Walker commented that for wedding rentals the Event Center needs a higher end (product), and it would be better to receive a Perry City residents' contribution. Ms. Johnson expressed her support for the purchase of Mr. Case's art piece noting that the office staff was also in support and mentioned a few sources of pictures the City may also want to review from the Compton Collection for historical art that could also be displayed at the City. Council Member Wright commented on using high quality prints. Mayor Jeppsen highly recommended the council consider this artwork proposition. Council Member Tueller stated that he would like to enhance the lodge for the Event Center and was not opposed to making it a nice show piece.

**MOTION**: Council Member Walker made a motion to approve the art proposal from Garry Case as presented with the scene and for the dollar amount of \$4,000.
