#### **SNOW REMOVAL**

It is that time of year for the weather to bring snow! To allow for snow removal, this is a reminder to remove any motor vehicle, trailer, camper or any other obstruction from parking along public streets during, or within 48 hours immediately following snowfall. Also, homeowners are responsible to keep sidewalks adjacent to their property cleared to be compliant with Perry City ordinance and to reduce their personal liability. It is unlawful to push or blow snow onto city streets so please be mindful of this as you are clearing your driveways and sidewalks. We ask for you to please be patient after a snowfall, our Public Works Department is out working hard to get the roads cleared and as they move the snow it might cause a pile in your driveway. They start with the main roads first and then move to residential streets and culde sacs.

### PERRY CITY HIGHWAY 89 MASTER PLAN





Perry City, in partnership with Wasatch Front Regional Council (WFRC) and Utah Department of Transportation (UDOT) are preparing the Perry City Highway 89 Master Plan. The Plan will identify community-focused improvements that support both residents and regional travelers. We want your input on corridor current corridor conditions, needs, and vision.



#### WHAT'S HAPPENING

- Hwy 89 Master Plan Open House scheduled for January 30th. Grant funding has been obtained via WFRC and UDOT.
- Lodge/City Hall Complete (Nov 2023).
- Historic Orchard Pathway (1200 W Trail) 3600 S to 2450 S Some delays have been encountered coordinating power pole locations with Rocky Mtn. Power. Construction to begin in 2024. Anticipated to be covered 100% by grant funding. Project to coincide with significant road improvements and adjustments to 1200 W 2450 S to Brigham City. Construction anticipated in 2027 and anticipated to be funded primarily by grant funding.
- Well #5 (new culinary water well). Legal preparation is ongoing and engineering and design work is forth-coming. Construction is tentatively anticipated 2026-2027. Funding sources include federal ARPA funds and local Impact Fees.
- Generators for Well #3 and #4 Majority of costs covered by FEMA grant funding. Construction is anticipated in the summer of 2024.
- Community Forestry Partnership Grant Recently Awarded. This grant will provide for tree maintenance as well as a tree inventory, management plan, and updated ordinance.
- State Building Construction (located behind the Bridgerland Technical College and the Driver's License Division) – This is a state project that will house Highway patrol services, dispatch, and the Driver's License office.
- Impact Fee Update Perry City is updating the impact fees for water and parks. These fees apply to new development. Study should be complete and new fees adopted.
