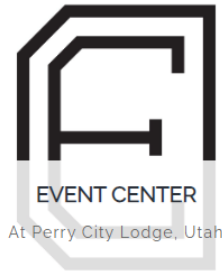




GUN RANGE

Three Mile Creek Gun Range 2024 season will open Saturday, March 23rd. Fee is \$12.00 per person or \$48.00 for a 5-punch pass, each with a 2-hour time limit. Also, individual and family season passes are now available to purchase at the Perry City office.

Centerfire rifles, black powder guns and handguns can be fired. Shotguns cannot be fired during public hours. Metal targets are at the following distances: 200 Meters (220 Yards), 300 Meters (330 Yards), 385 Meters (420 Yards), 500 Meters (545 Yards), 540 Meters (590 Yards), 617 Meters (675 Yards), 772 Meters (845 Yards) and 914 Meters (1000 Yards). There are various sizes at each range. Paper target backers are posted at 50, 100 and 200 yards. Paper targets are available for sale while supplies last, or you can bring your own.

WHAT'S HAPPENING

- **Hwy 89 Master Plan** – Public comment has been gathered. Consultants will draft a plan based on feedback and another open house will be scheduled later this spring.
- **Historic Orchard Pathway** (1200 W Trail) 3600 S to 2450 S – Some delays have been encountered coordinating power pole locations with Rocky Mountain Power. We are hoping to bid the project in March. Anticipated to be covered 100% by grant funding. Project to coincide with significant road improvements and adjustments to 1200 W 2450 S to Brigham City. Construction anticipated in 2027.
- **Well #5 (new culinary water well)** – Legal preparation is ongoing. Engineering and design work is forthcoming. Construction is tentatively anticipated 2025-2026. Funding sources include federal ARPA funds and local Impact Fees.
- **Generators for Well #3 and #4** – Majority of costs covered by FEMA grant funding. Construction is anticipated in the summer of 2024.
- **Community Forestry Partnership Grant** – This grant will provide for tree maintenance as well as a tree inventory, management plan, and updated ordinance.
- **State Building Construction** (located behind the Bridgerland Technical College and the Driver's License Division) – This is a state project that will house Highway patrol services, dispatch, and the Driver's License office.

We have only provided basic information on each topic and there are many more projects and endeavors occurring in Perry City behind the scenes. We also recognize that each of our many residents will have varying opinions on the validity and value of each city project.
