

Three Mile Creek Shooting Sports Complex

WAIVER, RELEASE, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF RISK AND LIABILITY AGREEMENT

I, _____, wish to engage in firearms shooting, camping, or other activities at Three Mile Creek Shooting Sports Complex ("TMCSR"), Perry City, Utah 84302. I may also use a gun that is loaned to me owned by Perry City or another third-party for my use while at TMCSR.

This being the case, I understand that engaging in these activities may be hazardous, with accompanying risks of personal injury, death, and/or loss or damage to my property. In consideration of my participation in such shooting activities, I, on my own behalf, and that of my heirs, successors, representatives, administrators and assigns, hereby:

1. Waive and completely and fully release any and all past, present or future claims, causes of actions, suits, rights, damages, costs, expenses or obligations of demands of any kind whatsoever, I, or anyone on my behalf might allege against TMCSR, Perry City, Perry City Police Department, range safety officers and volunteers, employees of Perry City or their representatives or the owner(s) of a firearm that I rent, borrow or otherwise use that is not mine, for any loss, damages, personal injury, death and/or loss or damage to my property in such shooting, camping and/or other activities at the facility.
2. Agree to indemnify, defend, and hold harmless Perry City, Perry City Police Department, range safety officers and volunteers, employees of Perry City or their representatives for any loss, damage, personal injury, death and/or loss or damage to my property arising in any manner out of my participation in such activities.
3. Assume all risks associated with such activities and all responsibility for any medical expenses, costs and/or other obligations and other losses or injuries suffered by me arising out of my participation in such activities.
4. Agree that there shall be no illegal drugs or alcohol on the premises including parking lots, camping areas, structures, and I shall not be under the influence or illegal drugs or alcohol while on the premises including such times that I am not actively participating including observing, volunteering, working or participating in any way in the event(s).
5. Understand the violation of any term of this agreement or the rules of TMCSR will result in the forfeiture of my opportunity to use the TMCSR and its facilities.
6. Certify that I am 18 years or older and have read and understand this Wavier of Liability and voluntarily executed the same. In the event that the individual is understood the age of 18, a parent/legal guardian **must** sign the waiver.

My Commitment to Safe Gun Handling

Anyone who uses a firearm has the responsibility to themselves and others to use the firearm safely. I acknowledge that I am familiar with the basic rules of firearm safety and that those basic rules have been explained to me. I agree to follow all of the basic rules of firearm safety at all time during my use and handling of any firearm while at TMCSR.

I will treat every firearm as if it is loaded.

I will always keep the firearm pointed in a safe direction.

I will not place my finger on the trigger or in the trigger guard unless and until I am ready to fire.

I will always wear the appropriate eye and ear protection.

I will never pass the firearm to anyone without opening and keeping open the cylinder or the action to verify that it is unloaded.

I will always follow the commands of the range officer.

I understand these basic rules of firearms safety and I agree to follow them.
