RESOLUTION TO CANCEL THE NOVEMBER 21, 2023 MUNICIPAL ELECTION

A RESOLUTION OF THE TOWN OF CLEVELAND, UTAH, CANCELLING THE NOVEMBER 21, 2023 MUNICIPAL ELECTION IN ACCORDANCE WITH STATE LAW; AND PROVIDING AN EFFECTIVE.

WHEREAS, the Town of Cleveland (hereafter "Town") is a municipal corporation duly organized and existing under the laws of the state of Utah;

WHEREAS, Utah Code Annotated 20A-1-206 provides for cancellation of a municipal election in the event that the number of candidates does not exceed the number of open municipal positions up for election;

WHEREAS, the number of candidates in the Town does not exceed the number of open municipal positions up for election;

WHEREAS, the filing deadline for write-in candidates has expired on September 18, 2023;

WHEREAS, the Town desires to save costs of holding an election in 2023;

NOW, THEREFORE, be it resolved by the Town Council of the Town of Cleveland, Utah as follows:

Section 1: Findings of the Town Council.

In accordance with Utah Code Annotated 20A-1-206(1)(a)(i)(A), the Town Council finds that all municipal officers are elected in an at-large election, and (B) the number of municipal officer candidates, including any eligible write-in candidates under Section 20A-9-601, for the at-large municipal offices does not exceed the number of open at-large municipal offices for which the candidates have filed.

Section 2: Cancellation of November 21, 2023 Municipal Election and Election of Candidates. Based upon the forgoing findings in Section 1 above, the November 21, 2023 municipal election of the Town of Cleveland, Utah, is hereby cancelled.

Be it further resolved that Utah Code Annotated 20A-1-206(1)(b), (c)(i)(A) & (B):

There are two candidates for two at-large town council seats,

There is one candidate for one at-large mayoral seat,

There are no municipal ballot propositions.

The following candidates are considered to be elected to office:

Preston Wilson, two-year mayoral seat

Danae' Jensen, four-year council seat

Chance Thompson, four-year council seat

Section 3: Notification.


The City Recorder is hereby authorized on behalf of the Town Council to issue the notice set forth in Utah Code Annotated 20A-1-206(2).

Section 4: Effective Date.


This Resolution shall be effective immediately upon passage and adoption.
