Minutes of the Salem City Council Meeting held on January 4, 2023, in the Salem City Council Chambers.

### 1. AGENDA ITEMS DISCUSSION

Bruce Ward talked about the citizens request from Garnet Kutterer. Bruce Ward believes that Garnet Kutterer will be addressing the City Council about receiving a reduced pressurized irrigation bill. Bruce Ward stated that people who don't use a lot of pressurized irrigation during the season will see a reduction in their pressurized irrigation bill when the pressurized irrigation is metered. Salem City plans to begin metering pressurized irrigation this upcoming pressurized irrigation season.

Bruce Ward talked about the proposed Parkview Meadows Final Plat Subdivision extension. Reed Park (Landowner) has proposed to receive an extension for the Parkview Meadows Final Plat Subdivision approval. The proposed extension has been submitted to Salem City because of the recent downturn in the economy. Reed Park is proposing a six-month approval extension.

Bruce Ward shared information about the proposed Elk Ridge Interconnect Connectors Agreement. Bruce Ward stated that the Elk Ridge Interconnect Connectors Agreement was approved at a recent City Council. The Connectors Agreement is coming back for reapproval because the developer proposed changes to the Connectors Agreement. The proposed change is to remove the Mount Loafer Meadows Subdivision expect for Plat E from the Connectors Agreement's area. This adjustment will increase the payment from \$164.72 to \$188.82 per lot. City Staff recommends approval of the revised Elk Ridge Interconnect Connectors Agreement.

Chief Brad James and Walter Bird discussed the architect contract agreement for the New Fire/EMS Station. The agreement spells out the duties of the architect and the city during the New Fire/EMS Station project. City Staff has reviewed the agreement and feel comfortable with the price and services spelled out in the agreement. Chief Brad James shared the budget for the New Fire/EMS Station project. The project is currently on budget for this month. Salem City will be using public safety impact fees to fund the cost of the New Fire/EMS Station for the first few months of the project. Salem City is planning to bond for the project in a couple months. The New Fire/EMS Station is scheduled to be complete in April 2024.

### 1. VOLUNTEER MOTIVATIONAL/INSPIRATIONAL MESSAGE

Mayor Christensen asked if anyone would like to give a motivational or inspirational message. Mayor Christensen stated he would like to offer a motivational message in the form of a prayer.

### 2. INVITATION TO SAY PLEDGE OF ALLEGIANCE

Councilperson Sorensen invited those who wish to participate, to stand and say the pledge of allegiance with him. He then led the pledge of allegiance for those who wanted to participate.

### 4. SF/SALEM CHAMBER OF COMMERCE

Kathleen Leavitt was present at tonight's City Council meeting. Kathleen Leavitt is the President/CEO of the Spanish Fork/Salem Chamber of Commerce. The annual awards gala installation banquet will be held on January 25, 2023, at 6:30 p.m. at the river bridge event center.

### 5. CITIZEN REQUEST: GARNETT KUTTERER

Garnett and Kevin Kutterer came to City Council to petition their pressurized irrigation bill. The Kutterer family participated in the CUWCD flip the strip program last year. The

Kutterer's have made the planter strip and their yard water wise. Garnett Kutterer believes that their pressurized irrigation bill should be reduced because they don't use a lot of pressurized irrigation. Councilperson Sorensen mentioned that people who don't use a lot of pressurized irrigation will see a reduction in their bill when pressurized irrigation is metered. Salem City is planning to begin metering for the 2023 pressurized irrigation season. Garnett Kutterer wanted to know why they get a bill every month for pressurized irrigation when they don't use pressurized irrigation every month. Councilperson Sorensen explained that the monthly pay rate is charged for the purposes of maintaining the pressurized irrigation system. The City Council appreciated the Kutterer family for xeriscaping their yard. Councilperson De Graw asked the Kutterer family to send the City Council pictures of the xeriscape yard in the summer. The City Council can use these pictures to share examples of xeriscape yards to residents looking for xeriscape ideas.

# 6. DECISION: PARK VIEW MEADOWS FINAL PLAT SUBDIVISION EXTENSION

Bruce Ward stated that Arive Homes was required to construct an emergency back up water valve which interconnects the Elk Ridge and Salem City water systems. The interconnect was needed because the Salem City water line in the area was the end of a long dead-end line. Arive Homes was not required to construct the interconnect system until Mount Loafer Meadows Plat E was constructed. Therefore, all of Mount Loafer Meadows except for Plat E is not included in the Connectors Agreement.

Matt Marziale mentioned they have been working with Ames Construction through some road closure issues for the CUWCD pipeline project. Ames Construction is planning to be constructing around Foothills Elementary along Salem Canal Road. Ames Construction has been talking to Salem City about opening 600 South to alleviate traffic congestion. 600 South will be a one-way street to the east if it is opened. Ames Construction will improve the road to fill in the potholes and paint a pedestrian path. 600 South will be a fully improved two lane road once it is fully improved in the future. Mayor Christensen and the City Council wanted to know if the residents along 600 South were okay with the road opening. Matt Marziale stated that most of the residents along 600 South are in favor of the road opening.

It was mentioned that the water is being restricted from entering beer creek and draining out of the area because of an insufficient pipe underneath Mt. Loafer Parkway (currently under construction). Bruce Ward stated that the snow and rain combo over the past few weeks is the reason for the excess water in the area around 460 West.
