Minutes of the Salem City Council Meeting held on October 19, 2022 in the Salem City Council Chambers.

Work Session: 6:30 p.m.

1. Agenda Items Discussion

Bruce Ward mentioned that some announcements needed to be made before the agenda items are discussed in work session.

Dale Carter (MS4/SWPPP coordinator) explained that the two and a half year storm drain audit from DEQ is complete. Dale Carter stated that Salem City did not receive any fines from DEQ's audit. Dale Carter mentioned that most Cities are fined when DEQ's audits are performed. Dale Carter stated that the City could've been fined hundreds of thousands dollars. Dale Carter asked the City Council for support as needed storm drain infrastructure is proposed to be constructed in the future.

Dan Grinder representing Niels Fugal Sons Company addressed the City Council. Dan Grinder stated that Niels Fugal Sons Company's headquarters have been located in Pleasant Grove, Utah for ninety eight years. Dan Grinder stated that Niels Fugal Sons Company would like to locate its headquarters to Salem, Utah for the next one hundred years. Dan Grinder explained that Niels Fugal Sons Company has purchased property for their new headquarters location along 460 West. Niels Fugal Sons Company is hoping to have a 2024 move in date. Dan Grinder stated that they are looking to subdivide the west portion of the property. Niels Fugal Sons Company is looking to build a gas station and/or sale the subdivided parcels for light industrial use on the west side of the property. Councilperson De Graw wanted to know what the building and site improvements would be. Dan Grinder stated that there will be one building with a construction yard behind the building. Bruce Ward stated that the required frontage improvements will be addressed during the subdivision phase. Dan Grinder stated that Niels Fugal Sons Company is excited to relocate to Salem, Utah.

Walter Bird discussed the proposed resolution for authorizing the eminent domain action by Salem City against Carol L. Miller for a portion of parcel 30:046:0008. Walter Bird stated that the City needs thirteen hundred square feet of Carol Miller's property to construct necessary improvements along Salem Canal Road. The abandoned home located on the property will need to be demolished because the abandoned home is located where the road improvements will be constructed. Walter Bird stated that a real estate contract has been sent to Carol Miller for purchase of the property. Carol Miller has not returned a signed real estate contract for the property. Walter Bird mentioned that the City hired a real estate agent to help with the signing of the real estate contract and has also sent letters to Carol Miller about signing the real estate contract. Carol Miller had not responded to the City about the real estate contract despite these efforts. Walter Bird stated that Carol Miller called his office phone this afternoon. Walter Bird stated that he and Carol Miller had a conversation on the phone this afternoon about the property. Carol Miller is not in favor of eminent domain on the property. Walter Bird mentioned that the proposed resolution authorizing eminent domain does not file the law suit for eminent domain but gives the City authority to file the

law suit for eminent domain if needed. Walter Bird stated that Carol Miller and the City will try to resolve this issue with the real estate contract before eminent domain is filled. Walter Bird recommended that the City Council should approve the proposed resolution regarding eminent domain. Walter Bird stated that the real estate contract and proposed resolution can work parallel with each other. Walter Bird mentioned that Carol Miller told him that there was a water well on the property. Carol Miller requested that the water well will not be demolished.

Jeff Nielson explained the proposed resolution setting financial parameters for the construction of the electrical building. The parameters are as follows: bond amount cannot exceed \$4,500,000.00, bond length cannot exceed 21 years, bonds cannot be sold at a price more than 98% of the total principal, and the interest rate for the bond cannot exceed 6%. Johnathan Ward mentioned that the resolution strictly outlines parameters for the bond and not specifics. Johnathan Ward stated that the Mayor and the City Recorder are given the authority to determine the specifics of the bonding for the electrical building. Councilperson Snyder asked if the bonding needs to be in place quickly to avoid higher interest rates. Johnathan Ward explained how interest rates are determined. Johnathan Ward advised that the City has a little bit of time to complete the bonding in place before interest rates increase.

a. RESOLUTION AUTHORIZING THE FILING OF EMINENT DOMAIN ACTION BY SALEM CITY AGAINST CAROL J. MILLER FOR A PORTION OF PARCEL #30:046:0008 (APPROX. 816 W SALEM CANAL ROAD)

Walter Bird addressed the proposed eminent domain resolution. Walter Bird stated that the City needs 1300 sqft of parcel 30:046:0008 for right of way improvement purposes. Walter Bird stated that a signed real estate contract for the property was sent to the property owner Carol J. Miller a year ago. The City has not received a fully executed real estate contract for the property. Walter Bird mentioned that he and Carol Miller talked on the phone this afternoon. Carol Miller is opposed to the proposed eminent domain. Walter Bird recommended that the resolution for eminent domain is approved at tonight's meeting. Walter Bird stated that the City will try to resolve this situation through a real estate contract before eminent domain is filed to the court. Councilperson Snyder mentioned that the real estate contract for the property has not been executed because the City has not been able to contact Carol Miller. Councilperson Snyder stated that the City has given the property owner a lot of opportunities to execute the real estate contract. Councilperson De Graw suggested that the proposed resolution for eminent domain could be tabled until the November 2, 2022 City Council meeting. This would give the City time to execute the real estate contract with the property owner without a resolution allowing eminent domain to be filed. Walter Bird recommended that the proposed resolution is approved at tonight's meeting. Walter Bird stated that the proposed resolution and real estate contract can work parallel with each other.

Mayor Christensen asked for public comment. Public comment was not shared during this public hearing.

Councilperson Snyder believed in the past that Carol Miller did not know about the real estate contract because of the lack of communication from Carol Miller. Councilperson Snyder believes now that Carol Miller knows about the real estate contract. Councilperson Snyder believes that the eminent domain resolution should be approved because the approved resolution may encourage Carol Miller to sign the real estate contract in a timely manner.

9. DECISION: AERO RUGER RIFLES

Chief Brad James read the following regarding the Aero Ruger rifles. The Police Department currently has eleven Ruger 556, AR-15 long gun rifles that are assigned to officers. These long guns are made available to officers for volatile situations such as an active shooter situation. During a recent active shooter training it became evident that our current long guns are not efficient or practical for in-door or close combat situations. The Department is asking that we surplus the current rifles and sell them to, "Gunnies INC" who is a Licensed Federal Firearms Dealer for the amount of, \$4,290.00. As a replacement the Department is asking authorization to purchase 12 M4E1 carbine rifles from Aero Precision for the amount of, \$8,999;88. The police department submitted and received a Local Law Enforcement Block Grant (JAG) from Criminal & Juvenile Justice Commission in the amount of \$3500. This grant has been authorized to supplement the purchase of the Aero Precision rifles.

Mayor Christensen asked for a motion for the Aero Ruger rifles.

They have a responsibility of improving public safety communications in Utah. They are upgrading to a P25 trucked radio system. This P25 upgrade will result in a number of older radios not being compatible with the new system. The Salem Fire Department has upgraded to compliant radios resulting in the need to surplus their old ones.
