

# Salem City – Loafer Soccer Park hydroseed

Location: 390 East & 500 East Salem Canal Road, Salem.

Submission of a Proposal shall be considered prima facie evidence that the bidder has made such examination and is satisfied as to the conditions to be encountered in performing the work and as to the requirements of the Plans, Specifications, and other Contract Documents.

1. Kentucky bluegrass 80%, perennial ryegrass 20%.
2. Bid Submittal is (Closed Bid) opening – Wednesday, August 27<sup>th</sup> 4:45p. Salem Council Chambers.
3. Bid award – verbal will take place August 29<sup>th</sup>
4. Contract will be signed September 3rd
5. Work Start - date is September 4th.
6. Park size is **194,040 feet flat area**
7. Slanted side hill (North side of park) **14,600 square feet**
8. **208,640 square feet. Just shy of 5 acres.** Additional footage will pay at the approved bid rate.
9. All insurance requirements must be met at the time of bid submittal.
10. 1 year performance warranty required.
11. Payment (50%) will be available at award. 45% will be paid upon completion (City pay cycles) upon completion and final walk through. 5% retained for one month from completion date. This will be a quality bond. All payments require invoicing. (City pay cycles)
12. Onsite visual **pre bid walk through** will be **scheduled upon request.**
13. **Completion date is Wednesday, September 10<sup>th</sup>, 2025**

Bids shall be delivered to Salem City on or before the day and hour set for the opening of bids in the Notice Inviting Bids as published. Bids shall be enclosed in a sealed envelope bearing the title of the work and the name of the bidder. It is the SOLE responsibility of the bidder to see that his bid is received in proper time. Any bids received after the scheduled closing time for receipt of bids will be returned to the bidder unopened. Bids for this project are due August 27<sup>t</sup>, 2025 – 4:45p Salem City office.

All bids shall be made in accordance with applicable statutes of the State of Utah, APWA's Manual of Standard Specifications, APWA's Manual of Standard Plans, Salem City Standards and Specifications, applicable local laws, and as specified in this Book of Specifications

**COMPETENCY OF BIDDERS** In selecting the lowest responsible bidder, consideration will be given to the general competency of the bidder for the performance of the work covered by the bid. To this end, each bid shall be supported by a statement of the bidder's experience as of recent date on the form entitled "INFORMATION REQUIRED OF BIDDER", bound herein. **Must provide three references with jobs completed of at least 2 acres of seed applied.** No contract award will be made to a Contractor whose firm and Project Superintendent have not satisfactorily completed projects of similar type, complexity and comparable value and whose firm and Project Superintendent have not been in the contracting business for similar work for at least three (3) years. In addition, the Project Superintendent meeting this experience criterion shall be dedicated to the project. After an award of the contract, no substitution of the Project Superintendent will be allowed without the written approval by the Owner

**EXECUTION OF CONTRACT** The successful bidder shall execute and return the contract to the Owner no later than 5 days after the date of the Notice of Award

**AWARD OR REJECTION OF BIDS** Owner reserves the right to reject any and all bids or schedules of bids, to waive any and all informalities not involving price, time or changes in the work, and the right to disregard all nonconforming, nonresponsive, unbalanced or conditional bids. The Owner further reserves the right to reject the bid of any bidder if Owner believes that it would not be in the best interest of the project to make an award to that bidder, whether because the bid is not responsive, or the bidder is unqualified or of doubtful financial ability or fails to meet any other pertinent standard or criteria established by Owner. Owner may conduct such investigations, as Owner deems necessary to assist in the evaluation of any bid and to determine the responsibility, qualifications and financial ability of the bidder to perform and furnish the work. The award, if made, will be within 5 days after the opening of bids

**TIME OF COMPLETION** The Contractor shall commence work on or before the tenth day after receiving a written Notice to Proceed from the Engineer on behalf of the Owner and **shall fully complete all work under this Contract by September 10, 2025**. The Contractor shall at all times during the continuance of the Contract prosecute the work with such force and equipment as are sufficient to complete it within the time segments specified. See liquidated damages.

**PERMITS AND LICENSES** – Water meter and backflow prevention. Both are required. Coordinate with Salem Public Works prior to the start date of application. Communication must be at least 24 hours prior to start of project.

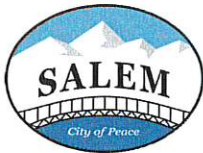
**LIQUIDATED DAMAGES** Liquidated damages shall be one-thousand dollars (\$500) per calendar day

**CONTRACTOR'S INSURANCE GENERAL:** On all projects, the Contractor shall carry all insurance required by Federal, State, County, and local laws. The Contractor shall procure and maintain, during the life of the Contract, adequate fire, workmen's compensation, public liability, and property damage insurance. The specific requirements for insurance as set forth in these General Conditions shall be considered as minimum requirements. The Contractor shall furnish satisfactory proof of carriage of insurance, or satisfactory proof of an approved self-insured program, and shall submit to the Owner, before work on the Contract starts, certificates of all insurance policies, bonds, or self-insured programs. Neither the Contractor, nor any subcontractor, shall commence work under this Contract until the Owner has approved all required insurance policies. The certificates of insurance shall be attached to the Contract by the Owner and filed in the Owner's office. Certificates of said policies shall provide that if the said policy or policies be canceled by the insurance company during the term of the Contract, that thirty (30) days written notice prior to cancellation will be given the Owner. The Owner will retain insurance certificates. Insurance certificates shall set forth the following information and shall be signed by an authorized representative of the insurance company: Name and address of the insured. The location of the operations to which the insurance applies. **SALEM CITY GC 3-2 SALEM LOAFER SOCCER PARK - PROJECT 1, 2025** The number of the policy and the type or types of insurance in force thereunder on the date borne by the certificate. The expiration date of the policy and the limit or limits of liability thereunder on the date borne by the certificate. A statement that the insurance covered by the certificate applies to all of the operations on and at the site of the project, which are undertaken by the insured during the life of the Contract. Public liability and Comprehensive General Liability, completed operations broad form property damage insurance shall include elevator liability, water damage liability, and automobile liability including no owned and rented cars. A statement that all coverage is on an occurrence basis rather than an accident basis. A statement that "explosion, collapse, and underground" coverage is included. A provision that the policy or policies may not be canceled or reduced in coverage until at least thirty (30) days after written notice has been sent to the Owner. A statement that a cross

liability or sever ability of interests clause is included (unless a separate policy covering the Owner is provided). In lieu of an insurance certificate setting forth all the required information concerning the coverage's, a copy of the complete policy or policies may be furnished to the Owner. COMPENSATION INSURANCE: The Contractor shall take out and maintain Workmen's Compensation Insurance for all his employees employed at the site of the project during the life of his Contract. In case any work is sublet, the Contractor shall require each subcontractor to provide Workmen's Compensation Insurance for his employees unless the Contractor covers such employees. The above coverage is required unless such employees are covered by the protection afforded by the Contractor under a self-insurance plan or with a private carrier approved by the State Industrial Commission. In the event any class of employees engaged in hazardous work under this Contract is not protected by the Workmen's Compensation Statute, the Contractor shall provide, and shall cause the subcontractor to provide special insurance for the protection of such employees not otherwise protected. COMPREHENSIVE GENERAL LIABILITY AND PROPERTY DAMAGE INSURANCE: The Contractor shall procure, and maintain during the life of his Contract, such comprehensive general liability and property damage insurance necessary to protect him, the Owner and Rimrock Engineering and Development, or any subcontractor performing work under his Contract, from all claims for bodily injury, including accidental death and property damage claims arising from operations under this Contract, whether.

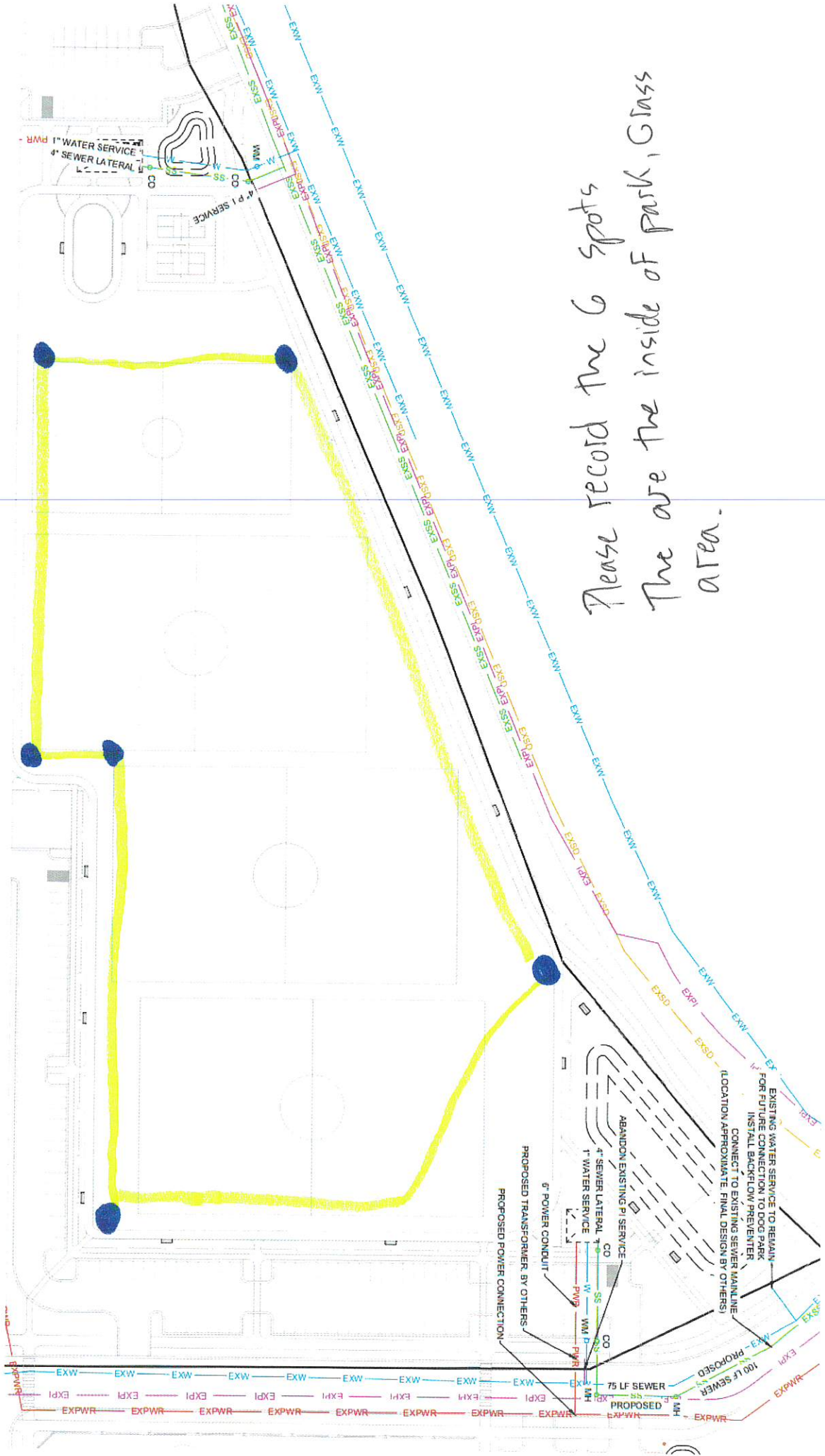
