Minutes of the Salem City Council Meeting held on June 7, 2017 in the Salem City Council Chambers.

Work Session: 6:15 p.m.

1. BUDGET DISCUSSION FY 2018

Jeff Nielson presented the budget for Fiscal Year 2017/2018.

Matt Marziale reported that the Addict to Athlete run/walk that will be introduced to the council is a good cause. The reason they are coming before the council is they have been told they would need to pay the cost to have officers along the run route. They would like to have that cost waived, or have volunteer officers from other cities. Matt stated he is in favor of the event, but not of waiving the fees. Mayor Brailsford stated that we appreciate their cause but they would need to pay for the public safety, and we would use our own officers.

Matt advised the council that we received two bids for the overlay project, including Salem Canal Road from 100 East to 500 East and the subdivision around 450 East and 600 South. Eckles Paving came in with the lower bid of \$1000/hour. This would include using their equipment and having five of their crew members working with our roads crew. Staker Parsons bid was \$1360/hour. We currently have the money in the budget to do this. Matt recommends accepting the bid from Eckles Paving.

Jason Sant reported that the ordinance amending the municipal code concerning the election requirements is just changing ours to meet state code.

Jeff Nielson reviewed the budget for Fiscal Year 2017/2018

5. CITIZEN REQUEST FOR A 5K RUN (ADDICT TO ATHLETE PROGRAM)

Jed Jensen, representing Team Addict to Athlete thanked the council for the time to address them. He stated that this is an annual 5K run to help raise awareness to addiction. They would like to hold it in Salem in remembrance of Brandon Black, who lost his battle with addiction after a relapse. His family lives in Salem. The request is for September 9, 2017, and they would like it to begin and end at the same place, either Salem Pond or the high school. This is a nonprofit run and they rely on volunteers. This run is free to the public. They have held runs in Alpine, Payson, Provo, Highland and Orem. He invited the mayor and the council to speak at the beginning of the race. Mayor Brailsford asked if there was any entry fee. Jed stated no, they just want people to come, to raise awareness for their cause. Matt Marziale stated that once they are firm on the route, they would need to find the streets where they would need to have officers present. Jed stated they would like the run to start at 9 a.m. He was asked how many people, he stated usually about 100 people there physically. They also do a virtual run, and have had up to 800 participants. Matt asked Chief Brad James how many officers would be needed. Chief James stated that they would need five officers. Matt asked what the cost would be, Chief James stated that they charge the triathlon \$1000. Councilperson Soren Christensen asked what funds they had to defer the cost of the officers. Jed stated that they do have some money and are looking for sponsors. Councilperson Christensen recommended regrettably not to hold the event in Salem, unless they could come up with the funds for the public safety. The council agreed they would be welcome if they could pay for the cost of the officers.

They would sell this as is, and the value would be the motor.

COUNCIL REPORTS

20. MAYOR RANDY BRAILSFORD

Mayor Brailsford reported that he and Bruce Ward will be working with Salem Canal Company to have them tell us the sizes and standards we need to be using, and sign off on these. Then we will have standards in place.

21. COUNCILPERSON STERLING REES

Councilperson Sterling Rees stated that the UMPA building is close to finished, but it will probably be July before they move in. He advised that the national UMPA meeting would be held next week.

22. COUNCILPERSON CRISTY SIMONS

Councilperson Cristy Simons invited the council and public to attend the first summer concert at Knoll Park on Monday June 12, 2017 at 7 p.m. She stated that we have great talent performing. Ernie's Food Truck will be at the concert, and there will also be concessions. She thanked the departments for their help with the preparation for the

concert. She commented that the chamber had inquired about an open house date for the Activity Center. Matt Marziale expressed that he was deferring that to Jen Wright.

23. COUNCILPERSON SOREN CHRISTENSEN

Councilperson Soren Christensen reported that the SUVMWA meeting will be held tomorrow, they will be discussing selling property. They have looked into wetland mitigation but in talking to other cities, have found it isn't worth the time or effort. Councilperson Christensen explained that we did not have the PI usage numbers. Bruce Ward commented that we had given out 20 warnings about watering restrictions. Councilperson Christensen reminded residents that there is no watering on Tuesdays and no watering any day from the hours of 10 a.m. to 6 p.m. He asked that these limits be respected so that we do not to implement more restrictions. Councilperson Sterling Rees stated that Tuesday we need to fill the ponds.

24. COUNCILPERSON AARON CLOWARD

Councilperson Aaron Cloward asked if Matt Marziale would report on the upcoming bike ride and the proposed closure of 100 East. Matt stated that the bike ride will be held June 23 and 24, 2017. They have put a committee together, and that committee is assuring him that we will have 60 riders, right now we have 18. There will be three stages of the bike ride. Matt reported that 100 East is a half asphalt half dirt road that goes through Orchard Farms. We have had complaints from residents that 50 to 100 cars are speeding through the subdivision on this road. He has asked Chief Brad James and the roads department to do a study on the road. Matt stated the staff would like to put up barriers since this is not a public open road. The council felt that we should barricade the road. Matt asked if they could wait until Monday so they can do the study and have real numbers on what is happening on the road. The council stated that would be fine.

25. COUNCILPERSON CRAIG WARREN

Councilperson Craig Warren did not have anything to report tonight.

Jed Jensen with Addict to Athlete stated that they have the money to pay for the officers needed at their 5K Run on September 9, 2017. The council stated that they would be glad to have the run held in Salem.
