1. APPROVE AMENDED LESSOR AGREEMENT WITH STOKES

Attorney Junior Baker explained that a number of years ago the Redevelopment Agency was created as a separate legal entity to help with economical growth in the city. It isn't used a lot but it was used to help get the Stokes Grocery Store in Salem. The RDA leases the ground where the grocery store is located to Stokes. Stokes owns the building and everything inside. Stokes is in the process of a refinance and they are getting an SBA loan. Attorney Baker said there was one thing that he wanted to change, that was if Stokes defaults on the loan SBA will have the right to reassign the leasehold estate, but this is a requirement for an SBA loan. He stated it isn't too big of an issue because as they city we control the zoning. They are asking tonight to approve the lessor agreement that SBA have a trusted interest in the building, but not the land. He asked if there were any questions. He advised that Mayor Christensen, as the chairman does have a vote. Board Member Howard Chuntz commented that he couldn't see anything negative with the agreement. Attorney Baker said his only concern was that they have the absolute right to assign a successor. Chairman Kurt Christensen commented it would take a successful business to take it over, and this helps a major business in Salem. Attorney Baker stated he wasn't sure what they were doing with the money. Jeff Nielsen said they have already done the improvements to the store and used the money. Chairman Christensen commented that the he appreciates Stokes.
