INFORMATION YOU SHOULD KNOW

The North Newton Municipal Court has established a Diversion Program for some traffic offenders. Diversion is a privilege and not a right.

THE FOLLOWING VIOLATIONS ARE NOT ELIGIBLE:

- DUI
- Reckless driving
- Attempt to flee/elude
- Speeding more than 20 MPH over posted limit
- Construction or school zone violations
- Crosswalk violations
- Child restraint or seatbelt violations

To apply for diversion, fill out the application completely and submit a **non-refundable** \$25.00 application fee (cash, check or money order made payable to the "North Newton Municipal Court") within 14 days of receipt of the citation. Deliver in person or mail to:

If you meet eligibility criteria and are approved:

1. You will be notified. You and the City Prosecutor will sign the diversion agreement by a certain court date. You will not need to appear in court.
2. You will be required to pay the ticket fines, court costs and a \$100 diversion fee (\$200 for Open Container) when the agreement is submitted.
3. You must keep the Court informed of any change of address during the 6 month period.
4. Your driving record will be checked periodically.
5. If you incur another infraction or charge on your record, the North Newton diversion could be revoked and the original charge re-activated.
