Call to Order: Mayor Terrell called the meeting to order at 6:04 p.m.

Moment of Silence and Pledge of Allegiance: was led by Mayor Terrell

## Additions/Deletions to Agenda:

Trustee Hansen: requested that Water Restrictions be added under the Public Works Report.

## **Sheriff's Report:**

Sheriff Warwick submitted his report and stated that the new Stop Signs by school are being effective with speeding in the area.

## Belinda Zink, Architect Presentation on Historic Assessment of Community Building:

Belinda Zink, Architect, Zink and Associates, Inc. of Fort Collins conducted a presentation regarding finalization of the Historic Structure Assessment on the Saguache Community Building. The Report is 104 pages long, and a bound copy will be maintained at Town Hall for public inspection/review. Notable findings were the damp crawl space (vents need to be open in summer and closed in winter). Stucco over-all, walls and windows are in good condition. Ceiling needs maintenance soon. Handicap access is also needed. Town needs to decide whether to replace current heating system or update. Ms. Zink is open to any comments for review to be placed in report. Once finalized, the report will be turned in to History of Colorado and they have 30 days to review.

#### **Citizens' Comments:**

Mayor Terrell: We will now take citizen comments. Citizens are limited to 3 minutes per person.

Elvie Samora: asked Public Works Director Pacheco to expand on the Tree Board report during the Public Works Report.

Elvie Samora: inquired about the Mondragon property update.

Town Administrator Fye: responded that she is still waiting for a reply regarding the asbestos removal plan, and does not know yet if the contractor has submitted it to the State.

Sky Wright: inquired about the Chlorine levels on February 8, 2017. Sky commented that some people did not get the notice letter.

Public Works Director Pacheco: explained about State regulations for Chlorine and our pump mal-function, and that a notice letter did go out to all water customers.

Public Works Director: reported on a meeting attended by Public Works in Monte Vista that was solely focused on the Rio Grande, and stated there would be another meeting in Gunnison at the end of May. These meetings are open to the public.

2. Cost Information on Handicap Parking Signs for 4<sup>th</sup> Street and Otto Mears Park.

Town Administrator Fye reported on the costs (Engineer Grade Access Signs - \$10.37 each, and Van Accessible Signs - \$7.95 each), and the Board advised the Town should move forward with ordering and getting these installed.

Town Administrator Fye: reported that the Town did not budget in for paving in 2017, as there will be a large paving project at the end of the Sewer Project.

After discussion, the Board determined that they would like to see the request for estimates advertised in the paper and/or two to three additional carpenters called for estimates in order to make a determination to proceed with the work.

## Review/Discuss Sewer Tap for Barry Van Sant Property:

 Mr. Van Sant has requested a new sewer tap for his property, The Bunkhouse, located at 845 Gunnison Avenue. The new tap requires a permit from CDOT and a highway cut.

Public Works Director Pacheco: advised that he had met with Mr. Van Sant several times and that the original paperwork on this sewer tap was made back in December, 2016. At that time, the location of the tap was determined and shown to Mr. Van Sant. Mr. Van Sant and his contractor moved the location of the tap, now placing them under a requirement for a permit from CDOT, engagement of traffic flaggers and a traffic plan.

Mr. Van Sant read a statement that he disagreed and wants to be reimbursed \$500 - \$1000.00, for the cost of moving the tap back to its original location.

Town Administrator Fye: suggested that this situation be written and submitted to the Town Board at the next meeting, and the matter was tabled.

## Review/Discuss/Determine Action on Subdivision Exemption:

 Saguache County Land Use is requesting input and attendance regarding a request by Joe N. and Josephine J. Abeyta for a Subdivision Exemption to divide a parent parcel of land containing 11.47 acres more or less into two tracts. One tract will contain 10.47 acres more or less and tract 1 will contain 1 acre more or less. Present use of the property is agriculture and proposed use will be agriculture and parking.

The Town is receiving this notice because we are a taxing entity. Comments or concerns need to be addressed to the Land Use Office on or before April 12, 2017.

Does the Town Board of Trustees object to this subdivision exemption that is within 1500 feet of Town owned property?

No Objections were made by the Board.

Review/Discuss/Approve Intergovernmental Agreement for a Regional Planning Commission for Transportation Planning (San Luis Valley Transportation Planning Region):

1. In accordance with Section 43-1-1103 C.R.S. a Regional Planning Commission is required for regional transportation consisting of the areas within the counties of

Alamosa, Chaffee, Conejos, Costilla, Mineral, Rio Grande and Saguache. Each party to the agreement must designate one representative on the Commission.

Town Administrator Fye: advised that the Town has 10:00 pm curfew, and the Board would need to approve extending the curfew, as well as the noise nuisance for the music. No liquor will be served so security is not required.

MOTION: by Trustee Hansen to lift the 10 pm curfew and noise nuisance for this event, and allow the street closure on May 19, 2017 from San Juan Avenue to Christy Avenue, on Friday, May 19, 2017 from 4:00 p.m. until midnight.

## **Trustee Comments:**

Trustee Torrez: commented that the Town needs to consider the purchase of a newer Grader for Public Works and indicated that Public Works Employee Hammel advised her they had found a good rate of \$75,000. She encouraged the finance committee to check into the possibility.

Mayor Terrell: mentioned putting an ad in paper for Vista Grande Committee members. Clean up at Vista Grande to take place in June 2017.

It was suggested that the Town get input from citizens regarding what they would like to see done to the Dave Martinez Park.

Mayor Terrell and Mayor Pro-Tem Engquist reported that they will be out of the area for a while and it was suggested that the Trustees get an additional check signer on the accounts.

Public Works Director Pacheco reported on trees that need removal and/or are awaiting decisions regarding condition: Elvie Samora has one that needs to be looked at, and Lorraine Quintana has 3 trees submitted for removal requests.
