Old Business:

1. Tree trimming over private property.

The town clerk and the tree trimmers would like clarification on what to do if private property owners do not want them trimming the tree over private property and also how to safe guard the tree trimmer and the town if a property owner comes back later and says his property was damaged. Town clerk was asked to put addendum on September meeting agenda.

New Business:

1. **Fred Quintana and Merriel Quintana** – Mrs. Quintana requested that she be allowed to remove a berm on the ditch that provided water to the Saguache Creek Water Users on her property and the property south of her property on 14th and Christy which she is currently in the process of purchasing. The board advised Mrs. Quintana that the ditch was attached to water rights and that consultation with the Division of Water Resources would be necessary to ensure we are following all rules regarding the use of water.

2. Thomas Monaco Small Business Development Center

Mr. Monaco the new director for the SBDC wanted to come to introduce himself and let the board know that the SBCD is here to help the town and community when it comes to bringing businesses to town, starting a business or even helping with resources. He will be available for town citizens one day a month and will be located at the library. Mr. Monaco does not have a schedule yet but will call the Town Hall and inform them what day he will be here.

3. Tourism Council and GOCO grant ideas:

The town is looking at applying for a grant along with the GOCO grant to make upgrades to the parks. Town Clerk Garcia is looking for permission from the board to apply for this grant with the idea of possibly installing a water park at Otto Mears Park. The board would like to table this and schedule a work session to determine what project they would like to seek funding for.

4. Tourism Council – Transmedia storytelling

Ms. O'Reilly asked for a letter of support from the town to get a matching grant for the tourism council to start transmedia storytelling in place of print ads. The Tourism Council has 16 businesses from Saguache that have signed a joint letter of support. This will be highlighting just Saguache County.

The Board asked Attorney Farish to include the following language per state statute to resolution 2018-G: The governing body by ordinance may eliminate the board of adjustment's authority to grant use variances or use modification, or may transfer that authority to some other board, agency or commission, or to the governing body of the municipality.
