Luana Lovato – Had a citizen approach her and ask her a question regarding multiple sewer taps on his property and why he had to either abandon one and/or pay for the additional tap. Town Clerk explained that the town researched the taps and found that only one tap was paid for. The town sent out a letter regarding the use of the additional service line and that if the service line was in use it would require a secondary sewer fee monthly. Town Clerk Garcia pointed out that homeowner requested that the contractors who were installing the sewer lines replace the additional sewer tap. RESOLUTION NO. 2018-Z (Series 2018)

A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 2019, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF SAGUACHE, COLORADO, FOR THE 2019 BUDGET YEAR.

WHEREAS, the Town Board for the Town of Saguache will adopt the annual budget in accordance with the Local Government Budget Law,

WHEREAS, the amount of money necessary to balance the budget for general operating expenses is \$60,116, and

WHEREAS, the 2018 valuation for assessment for the Town of Saguache, as certified by Saguache County Assessor is \$2,754,414.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES FOR THE TOWN OF SAGUACHE, COLORADO:

- Section 1. That for the purpose of meeting all general operating expenses of the Town of Saguache during the 2019 budget year, there is hereby levied a tax of 21.820 mills upon the total valuation for assessment of all taxable property with in the Town of the year 2019.
- Section 2. That this mill levy of 21.820 mills remains the same as that levied by the Town of Saguache for the Budget year 2018 required under the Tabor Amendment as passed by electors on November 5, 2002.
- Section 3. There being no additional levy extended against the above listed assessment valuation of \$2,754,414 for refunds and abatements, the total mill levy is 21.825.
- Section 4. That the Town Clerk of the Town of Saguache is hereby authorized and directed to immediately certify to the County Commissioners of the County of Saguache, Colorado, the mill levy for the Town of Saguache as hereinabove determined and set.

Attorney Report:

Reported that he spoke with County Attorney Ben Gibbons regarding the MOU for the purchase of the broom from the Saguache County Road and Bridge.

Staff Reports:

- 1. Maintenance Report Public Works Director Helmick presented a written report and opened up for questions. Mayor Pro-Tem Jaminet clarified the process for mowing at the lagoon. Trustee Aldrich asked if Barry Van Sant also installed water taps. Director Helmick reported they had already been completed in the previous month. Mayor Pro-Tem asked if the improvement in influent levels at the lagoon was attributed to the sewer project. Director Helmick affirmed this. Trustee Collins asked if there was an alley on the property owned by Barry Van Sant. Mayor Samora noted that the alley had been vacated. Trustee Collins asked for mileage for all of the equipment.
- 2. Town Clerk Reported that she is still working with the EPA and CDPHE to hopefully facilitate a cleanup at the Mondragon property. There were several legal issues that were being discussed with CDPHE. If we do not qualify for EPA clean-up, we will need to explore different ideas which could include working with other companies and getting a waiver from CDPHE in regard to the type of cleanup we can do with that property. She also updated the board on the porch roof at the community building and discussed the quote for removal. The Barry Van Sant CDOT project was completed, the town's public works department completed the project rather than have RMS do the project. Reported the sewer line replacement on San Juan would be completed before Christmas and that we will ask that they make the roads passable and clean up the work areas. Trustee Collins asked about an email that I was to send out regarding the air valve at the school. Mayor Samora and other board members confirmed that they did receive the email.
- 3. Code Enforcement Report Written Code enforcement officer Sanchez reported on the ongoing cases and that the town has received compliments on the clean up being done on properties located in town. Trustee Collins asked about the burned RV located on 12th street and the other RV that is consistently parked on the road way at the same residence.

Trustee Comments:

Trustee Aldrich – Looks like we are off to a good start for 2019.

Mayor Pro-Tem Jaminet – Will have a conflict with January 14th meeting. Can we just move the regular meeting for January 2019 to January 3, 2019? RMS work is subpar and unhappy with how they are leaving the town. They are leaving trash and debris all over town.

Trustee Collins: What is the status of the town's Christmas Party. Clerk Garcia confirmed that the party was still scheduled for December 17, 2018 at 6:30 P.M.

Trustee Wilson: Thank you for the work at the tree lighting.
