We will now open up for the public comment we will not swear in those wishing to make a public comment. Usually these things do not precipitate much in the way of public comments. The Town Administrator would like to make a few comments on the supplemental budget.

So, the resolution is in front of you. There is one item we will have to change in the 3<sup>rd</sup> Whereas it should say and capital outlay. So, we do have some minor overages from what was budgeted in 2017, but nothing major. The general fund our original budget was \$451,609, we went over our original amount by \$17,112. That final amount there is \$468,721. The reason why we went over, we have some overages that we mainly on personnel in 2017 that comes out to about \$17,000. We did budget a \$60,000 deficit in the 2017 budget and that's a one-time fee. That one-time moneys were used for the town hall project and a couple of other things. Its typical for towns to pull out from their piggy banks and savings accounts for one-time projects, so there's no cause for alarm there. This is just making sure that what we spent is reflected in our approval of our legal documents. Our auditor will make those adjustments to our beginning balances, so what that means is that \$17,112 will come out of our beginning balance so it will be slightly over. We still maintain healthy reserves above that 30% threshold that was presented in our last budget. So, there's no cause for alarm we just want to make sure we account for it and be transparent where the public is concerned. Sometimes you don't really need to do a supplemental budget appropriation, but you really should its part of the budgeting. Sometimes you will collect more sales tax than what was budgeted but everything nets out and you have a positive I have seen not amend the budget in that case. The water and sewer fund the same thing. In 2017 we budgeted \$411965 we slightly over 5932 is the adjustment which leaves the final water and sewer fund budget at \$417,898. So, all in all we are looking at \$23,075 in total adjustments for 2017 and those will be reflected in our beginning balances when we work with our auditors. Other funds I don't have those here because we have positives in those accounts, the recreation fund, conservation trust fund and general improvement fund those all have positive balances. These are the ones I want to amend to reflect our actual balances. I will take any questions you have.

Mayor Pro-Tem Lovato: Brandy, can you pinpoint why we went over in the water and sewer fund?

Administrator Reitter: So, the water sewer project we spend quite a bit on design and engineering. Those expenses were budgeted but we have yet to get reimbursed from our design and engineering grant through CDPHE. I talked to Jerry Burgess just before we ended the year and asked that he write up everything related to water and sewer and the design, so we can

submit our grant to CDPHE and get reimbursed. If we can get that reimbursement soon then we can make that adjustment. It's all about timing because we have to do the auditors closeout for 2017, but we can always make that adjustment back to the water and sewer fund without getting to into the weeds. For now, I just wanted to go ahead and adjust just in case we aren't able to do that for 2017. But that's probably the biggest difference there Luana.

Mayor Pro Tem: Ok, Thanks.

Administrator Reitter: We have \$97,000 available to us to get reimbursed. That's part of our loan.

Attorney Farish: Are there any other comments? (none) If not there we will close the evidentiary portion of the hearing and remand this over to the Town Board of Trustees for action on the resolution.
