Discussion: Trustee Aldrich wanted to know if there should be more information describing storage containers and thinks the wording is vague. Attorney Farish points out that the wording is for illustrative purposes only. We can add language that describes it better. Mayor Pro-Tem Arredondo believes it explains it in section 1. Trustee Hansen asked how long this would go on since we do not have a planning commission. Multiple citizens asked for clarification on definitions and the study of other dilapidated properties. Moratorium will be for 6 months.

Mayor Pro-Tem Arredondo rescinded his motion so that it can be redrafted by Attorney Farish to include municipal language.

3. Resolution 2018 – P Amended Fire Ban Shortened -Version 2

Trustee Collins asked if bagged weeds could combust and asked that we add "materials subject to internal combustion". Trustee Hansen asked why they short version was presented rather than amending the long version? Attorney Farish explained they used BLM and other agency language to shorten the language.

Attorney Report:

Wanted to comment to the board regarding the variances. The town is mandated to have a Board of Adjustments. Giving variances puts the board in an awkward position by asking he board to vary from the ordinances they enacted and presents a public perception problem. Normally, variances are given for an undue hardship or other extreme situation that doesn't allow citizens to conform with code. Would have the board consider the implications of having to do variances themselves and try to get people together to create a board of adjustments, which will have the authority to deny or grant variances and appeals which will then go automatically to district court. The Board of Adjustment is not the same as the planning commission.
