#### **Attorney Report:**

Wanted to mention the municipal court, as we are constituted right now we are not a court of record. If we want to become a court of record, we have an attorney on staff and it wouldn't cost anything. It does away with appeals and increases our jurisdictional limit from \$300 to \$3000 dollars. If you would like to become a court of record, we would have to enact an ordinance.

Trustee Hansen asked if we could go back to a non-court of record at a later date if needed? Attorney Farish answered yes.
