Tina Sanchez – Hopes that if the board puts the marijuana question on the ballot that the board creates policy to regulate retail marijuana. Does not want the town to face problems seen within the County as a whole. Wants to see the town regulate placement and number of retail shops if passed. She also expressed concerns of homelessness and substandard housing condition that she feels can be attributed to marijuana issues and lack of regulations.

Kyle Grote – Respect the different opinions of the board on the subject of retail marijuana to preserve the quality of the town. Understands the fear of the town residents. Commented that grows do not use harmful pesticide and ensured the board that grow were highly regulated. He commented that his opinion is that The Town of Moffat has not seen an impact on town regarding police enforcement. Would like to open a shop in the Town of Saguache and asked that board consider keeping the ballot question a two-part question and to include manufacturing.
