Jarrod will be correcting the painting on handicap sites.

Mondragon Property -Discussed the dilemma on what to do with the asbestos abatement because the estimated cost came it at over \$137.000. Clerk Garcia let the board know she was working with the Environmental Protection Agency and Colorado Department of Public Health possibly to help with the abatement. She also stated that the board should consider other uses that would allow for use of grant funds. The Board of Trustees instructed Clerk Garcia to continue to explore other options.

Leigh Ann Buniger asked the status of the MOU with Saguache County to do Historic Structure Assessment on the Saguache Clinic. She would like to move forward with this project as soon as possible. Clerk Garcia asked that the HPC board request to be placed on the Saguache County Commissioners Agenda.

Attorney Report:

Attorney Report – Attorney Farish discussed the ballot for Marijuana and some of the issues we encountered with the wording. Attorney Farish asked the Secretary of State office to give some input on the structure. The Secretary of State suggested combining the question into one Tabor initiative for the retail marijuana and a second question for the medical marijuana issue.

Shared with the board the Town of Crestone zoning. Explained it is a pretty typical type of land use map and that if the Board of Trustees should decide to move towards zoning this could be a useful template to follow. He also asked the board if they were aware of the new liquor laws and how they will affect local stores. He discussed the removal of distinction between 3.2 percent and 6 percent beer designation.

Staff Reports:

Maintenance Report - Oral report: Public Works has gotten all the water testing back from the state. Mowed lagoons so the e-coli level would go down. Jarrod Helmick gave a briefing on jobs that they have been working on which included multiple water and sewer taps and locating water and sewer lines for RMS. The board asked if Public Works could give beginning and end mileages on the vehicles every month. Public Works also asked what the policy is for snow removal on how much snow must fall before they get out to plow. Policy states that at 2 inches of depth they are to start the plowing. Jarrod Helmick also asked if they could get clothing equipment for winter. Board approved that Public Works could get clothing equipment for them.

Town Clerk - Oral - Town Clerk has covered her report throughout the meeting.

Code Enforcement Report – Written- Code Enforcement has been busy handing out 2 complaint forms and working with law enforcement. Was asked by the board what Code Enforcement has on their plate for the month of November.

Trustee Comments:

Trustee Hansen: Talked about the sub water and wanted to know how the town is involved with Barry Van Sant and David Mixon when it comes to the sub water study they are doing. She also thinks everybody is pulling together and doing a great job.

Trustee Aldrich: The budget is looking the best he has seen since he has been on the board and really likes it.

Trustee Torrez: Everybody doing a great job.

Trustee Wilson: Thanks to all the staff for everything they do.

Mayor Samora: Likes the staff and thinks the 4 staff members are pulling evenly on the wagon. Would like to compliment the board for their thoughtfulness on items that come before them.
