Project Update by Interim Town Administrator -

Introduced newly hired staff to the town board and public, Tina Sanchez, Deputy Town Clerk and Iris Garcia, Town Clerk. Updated the board on existing projects: The collection system grant (sewer project) is in process and the design has been completed. The town qualified for a 100% grant from CDPHE for the planning grant has been reimbursed. The next steps for the sewer project will be a 30-day public notice for a public hearing prior to submitting the loan application by November 15, 2017. GOCO grant for \$15,000 as a pass through for Backyard to Back County will be distributed. Did not find a grant for the community building renovations. Updated the board on the progress and financial status for the Dave Martinez Park bathrooms and extension request. Update on Historic Preservation grant for the town hall building. Advised the board that security cameras were installed at town hall. The town is in the process of reconciling the town books and this will be an ongoing process. Vista Grande grant is still in process and is waiting for the environmental assessment to be completed and could take a while. Website grant will be placed on hold until the town has a chance to reorganize. Discussed the process for reviewing and accepting the 2016 audit. Let the town board know that the finances are not in good order and do not match bank records and let them know that it may take some time to get them straight. Administrator Reitter also presented the dog ordinances.

Chocolate Festival Representation- The town board authorized Iris Garcia and Tina Sanchez to represent the Town of Saguache at the chocolate festival.

Mountain Valley Referendum 3B- Trustee Arredondo asked that the town officially support the school in their efforts to improve the school.

Motion: Trustee Arredondo moved to support the Mountain Valley School district in their efforts to build a new school with a letter of support and that a resolution be established.

Discussion: Trustee Gillette has reservations on supporting this would like to have more information on the number as well as Trustee Collins and Trustee Chittum
