WHEREAS, said Ordinance approved standards and procedures necessary for the health, safety, and welfare of the citizens and city employees for the interconnection of such capacity with the City's electrical system, and

WHEREAS, the governing body finds that new standards and procedures should be adopted;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OXFORD, KANSAS, AS FOLLOWS:

SECTION 1: There is hereby adopted Interconnection Standards for Installation and Parallel Operation of Customer-Owned Renewable Electric Generation Facilities Dated April 5, 2022.

SECTION 2: The adopted Interconnection Standards for Installation and Parallel Operation of Customer-Owned Renewable Electric Generation Facilities Dated April 5, 2022 may be amended and modified in whole or in part by the Governing Body of the City of Oxford, Kansas, as deemed appropriate by the Governing Body.

SECTION 3: This Ordinance repeals any other preceding Ordinances.

SECTION 4: This Ordinance shall be effective after it is published in the official city newspaper.
