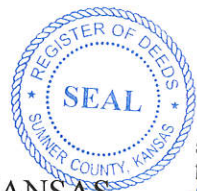

AN ORDINANCE REZONING CERTAIN OXFORD CITY LANDS WITHIN THE CITY OF OXFORD, KANSAS, FROM R-1 RESIDENTIAL AND I-2 INDUSTRIAL TO A-L AGRICULTURAL

WHEREAS, the Planning Commission of the city of Oxford held a public hearing on an application for the proposed zoning change, and a vote was held resulting in a 4 to 4 tie.

WHEREAS, after proper legal publication and notice pursuant to the statutes of the State of Kansas, a public hearing was held on October 8, 2019, at 7:00 p.m. at the Oxford City Hall, Oxford, Kansas; and

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OXFORD, KANSAS:

SECTION I

Change of Land Uses. The land uses for the following property located in the Original Town within the city limits of the city of Oxford, county of Sumner, state of Kansas, legally described as follows:

LEGAL DESCRIPTION:

Section 14, Township 32, Range 2 East, Block 72, Lots 1-8, vacated Pine St., Original Town, Sumner County, Kansas, presently zoned as "R-1" Residential and "I-2" Industrial, is hereby changed to "A-L" Agricultural

SECTION II

Amend Zoning District Map. That upon the taking effect of this ordinance, the above zoning change shall be entered and shown on the Zoning District Map, and said official zoning map shall be and is hereby reincorporated as a part of the Zoning Ordinance as amended.

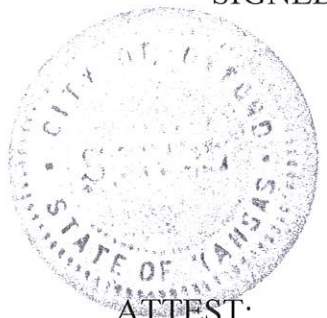
SECTION III
