ORDINANCE 337

ORDINANCE AMENDING ZONING REGULATION ARTICLE V, SECTION 1, DEFINITIONS #62 PERTAINING TO FENCES, ZONING ORDINANCE ARTICLE XXVI, SECTION 1, REGARDING DWELLING UNITS AND REMOVING THE TERM "COLLECTOR STREETS" FROM THE ZONING ORDINANCE, SUBDIVISION REGULATIONS, AND COMPREHENSIVE COMMUNITY PLANNING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OXFORD, KANSAS:

SECTION 1

Pursuant to notice and hearing before the City Planning Commission of the City of Oxford, Kansas and upon the recommendation of said Commission, Article V, Section 1, Definition #62 is amended to read as follows:

Fence – A free-standing structure of new materials such as chain-link, painted metal, masonry, glass blocks, wood, vinyl, or any combination thereof resting on or partially buried in the ground and rising above ground level and used for confinement, screening, or partition purposes.

SECTION II

Pursuant to notice and hearing before the City Planning Commission of the City of Oxford, Kansas and upon recommendation of said Commission, Article XXVI, Section 1, Dwelling Units is amended to read as follows:

1.d - Every dwelling unit shall be enclosed with an exterior wall surface, other than tar paper or galvanized metal.

SECTION III

The term "Collector Streets" is removed from the Zoning Ordinance, Subdivision Regulations, and Comprehensive Community Planning.

SECTION IV

Effective Date: This ordinance shall take effect and be enforced from and after its passage, approval, and publication in the official city newspaper, as provided by law.
