



## What Do You Get?

### Residential Efficiency Refunds

- \$75 for a new air conditioner with a 15 or greater SEER rating.
- \$75 for high efficiency residential electric water heater with an energy factor greater than 2.0.
- For high efficiency electric heat pumps with a SEER rating of 15 or greater:
  - \$200 for a unit larger than 1.5 tons per qualifying single-family structures.
  - \$150 for a unit larger than 1.5 tons per qualifying multi-family structures.
  - \$75 for any heat pumps 1.5 tons or smaller.
- Replace your old worn out refrigerator with a new efficient model and the City will buy back your unit for \$30.
- Reimbursement for a Level 2 Charging Station Unit up to \$1,500.

All appliances must be Energy Star Certified to qualify.

## Other Services

Kansas Power Pool offers general energy consulting and support services

- Purchase and installation of a new high efficiency heat pump(s) in a new residential structure; or
- Replacement of existing standard air conditioner with a heat pump. Natural gas or propane may be used only as a supplemental source.
- Qualifying equipment includes new electric heat pumps greater than or equal to 15 SEER.
  - This equipment must be inspected by the City before the application is approved. KPP will determine whether the equipment meets the program qualification.
