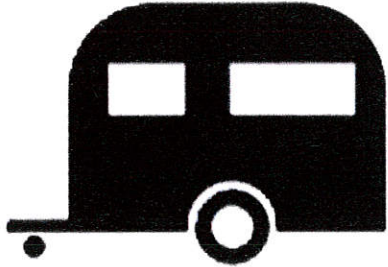

## NAPAWALLA PARK

The following rules will apply to ALL visitors and campers in Napawalla Park.

- Camping permits must be placed in window of camper or windshield of vehicle.
- All trash should be placed in the trash receptacles provided at various locations in the park.
- There will be no open fires. Fire rings are required.
- Pets must be kept on a leash, or under the owner's control at all times.
- There is no gray water dumping allowed in the campgrounds. Please use the dump station.
- Please observe the speed limit sign while driving through the park.
- City Ordinance 11-208 provides that noise levels should be kept down so not to disturb your neighbors.
- **Violation of City Codes &/or Ordinances shall cause eviction &/or being barred from camping privileges.**

- Golf carts/UTVs can only be used inside the park. If using outside the park, a license from the City is required. Please visit the Oxford Police Dept. for more info and license. After hours, please call (620) 326-2884.
- **All payments shall be made at the self-pay station located in front of the North shower house in Napawalla Park.**
- Restroom and shower facilities are available 24 hours a day during the camping season. The north restrooms and showers will be closed July 1<sup>st</sup> through July 4<sup>th</sup>. The restroom and shower facilities are closed from October 30<sup>th</sup> through April 1<sup>st</sup>.
- Camping fees are as follows: Campers that hook up to electric, will pay a rate of \$10.00 per day. Campers that do not hook up to electric (primitive camping), will pay a rate of \$3.50 per day.
- No person shall be permitted to camp for more than fourteen (14) consecutive days. At least five (5) days shall elapse between any and all camping periods.
- For Wi-Fi services at the park, contact Sumner Communications. You may be required to create an account, and you will need to pay by credit/debit card. For more information, call (620) 326-8989.
- **THE CITY OF OXFORD RESERVES THE RIGHT TO REFUSE SERVICE TO ANYONE.**
- **NO REFUNDS WILL BE GIVEN FOR UNUSED PAVILION RENTAL. CREDIT FOR UNUSED RESERVATION MUST BE USED WITHIN SAME YEAR AND IS SUBJECT TO APPROVAL.**

## CAVE PARK

The following rules will apply to all visitors and campers in Cave Park.

- Primitive overnight camping will be allowed in designated areas of the park at no charge. Adult campers, and juvenile campers who are accompanied by an adult, will be exempt from the curfew of Cave Park.
- All trash should be placed in the trash receptacles provided at various locations in the park.
- Pets must be kept on a leash, or under the owner's control at all times.
- Please observe the speed limit sign while driving through the park.
- City Ordinance 11-208 provides that noise levels should be kept down so not to disturb your neighbors.
- There are restroom facilities and an outdoor shower available in Cave Park.
- **FOR AFTER HOUR UTILITY AND OTHER EMERGENCIES, CALL 911 AND THEY WILL DISPATCH THE PROPER PERSONNEL.**
