The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, May 03, 2017 at 7:00 p.m.

The meeting was called to order at 7:00 p.m.

The following members were present: Roger Graham, Ken Carroll, Ed Burch, Eladio Reid and Mayor Pence. Attorney Irvine was present. Jim Arp was not present.

Mayor Pence invited the public to present comments to the governing Body.

#### Approval of Agenda:

Carroll moved to approve the Agenda. Seconded by Graham. Motion carried.

#### Approval of Minutes:

Carroll moved to approve the Minutes from the 04/ 19/17 Council Meeting. Seconded by Burch. Motion carried.

#### Angela Schnee, Zoning Administrator: Planning Commission and Board of Zoning Appeals Appointments.

Schnee commented that there are two positions that need to be reappointed. Schnee commented that Michael Coulter and Bill Robb have agreed to be reappointed.

Mayor Pence recommended the appointment of Michael Coulter and Bill Robb to the Planning Commission.

Burch moved to authorize Mayor Pence to appoint Michael Coulter and Bill Robb to the Planning Commission. Seconded by Reid. Motion carried.

#### Consider swimming pool fee increases.

Carroll moved to increase swimming pool fees. Daily admission for children from \$1.50 to \$2.00, Adults from \$2.00 to \$2.50. Yearly pass for children from \$30.00 to \$35.00, for adults from \$40.00 to \$45.00 and family pass from \$60.00 to \$65.00. Pool rental rates for 1-40 people from \$45.00 to \$60.00 and over 40 people from \$55.00 to \$70.00. Seconded by Reid. Motion carried.

City Foreman: Misc. items.

Nations commented that he didn't have anything for the Council at this time.

Burch commented that he felt that the radius of the turns on Riley and Walnut were too tight. Attorney Irvine inquired from city staff as to whether the design of the intersections and the placing of steel poles were approved by the engineer. He also requested engineer approval for what is on the poles currently or what should be on the poles for proper illumination.

Mayor Pence requested that Schnee consult the engineer to reassure that the City implemented the design for Riley Avenue to their specifications and get their approval for what the city has done to date.



Reid moved that the City continue to move forward in the process of securing an easement with Fort Riley on Ogden's west boundary. Seconded by Burch. Carroll voted against. Motion carried.
