The Regular Meeting of the Governing Body for the City of Ogden was scheduled on Wednesday, June 20, 2018 at 7:00 p.m.

The meeting was called to order at 7:00 p.m.

The following members were present: Ken Carroll, Quinn Jacobs, Ed Burch, Eladio Reid and Mayor Pence. Attorney Irvine was present. Russell Rohlman was not present.

Mayor Pence invited the public to present comments to the governing Body.

Approval of Agenda:

Carroll moved to approve the Agenda. Seconded by Burch. Motion carried

Approval of Minutes:

Carroll moved to approve the minutes from the 6/06/18 Council Meeting . Seconded by Burch. Motion carried.

Consider Ordinance #727. An Ordinance updating the Tree Ordinance.

Attorney Irvine presented the Council with two versions of the Ordinance. Version #2 is the original ordinance the Council considered and Version #3 is the ordinance with all the changes the Council recommended at the Work Session on June 11<sup>th</sup>.

Reid voted to adopt Version #3 of Ordinance No.727. AN ORDINANCE AMENDING ARTICLE 3, CHAPTER XIII OF THE CODE OF THE CITY OF OGDEN, KANSAS, PERTAINING TO TREES AND SCHRUBS. Seconded by Jacobs. Carroll and Burch voted against. Reid and Jacobs voted in favor. Mayor Pence voted in favor. Motion carried.

Terry Morrard; Discussion of Fireworks Night Display for 2019.

Morrard commented that in previous years they have used the VFW's distributor to buy the display, their magazine to store the display and their insurance. Morrard commented that as the display operator going forward, he would be responsible for everything. Morrard commented that he is not permitted to transport fireworks or have a magazine. He commented that he could get those permits through the ATF. However, it will take time and additional money. He commented that if the City required him to get his own insurance, which would be an additional cost as well. Morrard commented that he would propose a \$5000 budget for putting on the night display for 2019.

Morrard suggested having a work session in September to further discuss and plan for the display.

City Clerk: Misc. Items.


Clerk commented that the next Council Meeting falls on the 4<sup>th</sup> of July.
