4. GENERAL BUSINESS / DISCUSSION ITEMS / ITEMS PULLED FROM THE CONSENT AGENDA

a. Audit Committee and Risk Assessment

Mayor Jackson stated that the audit committee is a direct connection to the Risk Assessment. Information is included in your packet. It is up to the Council if this is something that we need to get going. The Auditors did suggest that Ferron City get this into place as this will be State mandated soon. Mayor Jackson has a few people in mind that he would like to ask to help with the Audit Committee. These people are master accountants. One of the individuals that is on the Castle Dales Committee would be willing to come and help get set up and trained. There are also people that are residents here in Ferron that could help also. The Council is encouraged to read through the information and the qualifications that are set fore in the documentation. They would meet once a quarter. They would look over the budget. Mayor Jackson advised that since Castle Dale has put an Audit Committee together their year end audits have cleaned up. The Risk Assessment score has also been much "higher" which is a good thing.

Council Member Richman asked if it was volunteer – Mayor Jackson stated that could be something that would be discussed. When he spoke to the people that helped with Castle Dale's Committee, they stated that they met once a quarter for about an hour. They pay about \$25.00 per hour.

Council Member Petersen asked if the State is requiring this could they help with financing it. Mayor Jackson stated that could be possible. As of right now it is not a requirement so it Ferron City would need to take care of it. It isn't required yet; however, it is strongly recommended.

Mayor Jackson asked that the Council look over the information, think about who they may want to have on the Committee. It would be three outside individuals and one Council Member. It would be on the agenda next month to discuss.

h. Review of Contract between Ferron City and CityWide, providing services for the Golf Course

It will be a detailed invoice. It will come out of the golf course advertising budget. Mayor has been advised that the marketing the course will receive year-round will be valuable to increase the revenue for the course. The Mayor will not approve the invoice if it does not come with proof.

a. BUDGET REVIEW

Barbara advised that we the city did receive the check from the Emery County Travel Board for \$15,000. That money is to help with the payment for the loan on the Golf Course. The peach day receipts have been received. There

were a couple of receipts that were posted wrong. They have been corrected. The Power bill will now be \$5,000 average a month.

b. MAYOR AND COUNCIL REPORTS

(1) Mayor Trent Jackson

Mayor attended the CVSSD meeting. Next year when we are preparing the "WISHLIST" for Ferron City perhaps we will just submit key items. They will be fixing the waterline and some curbs and gutters. He will have the information next time. An update on the speed signs was given. 5700 vehicles going west only 1800 were going the speed limit. 4300 vehicles going east... A lot of vehicles are going too fast. Council Member Mead suggested we readdress using the rumble strips. Mayor Jackson suggested that we post the link to the information on the signs on the website. Council Member Petersen talked about Molen Road being a priority. 500 South is also a candidate for signs. Sunshades we need for the signs.

(2) Council Member Brad Richman

Would like the city to concentrate on having the businesses keeping their yards cleaned up a little better. CLEAN UP THE JUNK. Wanted to recognize Ann Behling for her donation of the blanket to Peach Days. Dell Mead advised that he had recognized her at Peach Days.

(3) Council Member Ray Petersen

Need for equipment. Talked about the difference between a lease and paying cash. Surplus equipment. When the state gets rid of equipment it's usually rough, especially the snowplows. Citizen Randy Kenney suggested that we contact private businesses when they roll over their fleets. SB43 has changed a lot.

(4) Council Member Gerry Stotler

Sign for the metal dumpster. Something says that we are under contract so that only metal can go into that dumpster. Council Member Mead suggested that we have all our ducks in a row so when spring comes, we can get going on where the dumpsters are going to be placed. As a fire department they could even go up there and put a match to some of the junk. Is there a place on top of that property were we could put a burn pit.

Fire department has been pretty quiet. Animal control has also been quiet. Urban Deer wasn't taken advantage of. Council Member Mead explained the Urban Deer program. Citizen Randy Kenney asked what kind of Bow could be used?

Jared Howes, Ferron City rep for EEMSSD- Discussed with the City Council that was in attendance about the meeting of the Emery Emergency Medical Special Service District on October 3, 2023. The district will be hiring (2) part-time Coordinators or secretaries. These coordinators will also be EMT's. It was discussed at the meeting possible sites where the coordinators could have offices. Possibly they could use the office that is in the Ferron City Fire House. It was noted that this would help ensure that Ferron City would maintain ambulance coverage. The District will be setting up it's own liability insurance, payroll system, legal counsel, etc. Jared also advised the Ferron City Council of upcoming EMT training. Advised about the concerns involved with the eclipse viewing.
