3. GENERAL BUS./DISCUSSION ITEMS / ITEMS PULLED FROM THE CONSENT AGENDA

- a. REPORT FROM FIRE DEPARTMENT – Randy Kenney

ISO audit. Insurance companies use the rating to determine if the property is a high risk or not.

Unfortunately, we have had some residents who have been dropped by their insurance due to the Ferron City ISO rating. The fire department is working with the auditor to see what can be done to lower the risk. Will wait until they receive the report. Chief Kenney advised that winter fire school is coming up, sign up will be November 3. Ferron Fire is having Fire Safety week right now. Due to inclement weather the Saturday event will go to the Fire House instead of Mayor's Park.

- b. REQUEST TO ADDRESS THE COUNCIL – Merlin & Melody Weber

Presented a petition with 200 signatures to have the Stock Show Barn remain named "The Dennis Worwood Stock Show Barn". Merlin advised that he felt that Dennis deserved to have the barn named after him. He has done so much with the stock show. Merlin feels that there is a lot of commerce to the city due to the stock show. Mr. Webber stated that he felt that the kids and the stock show committee had envisioned the barn for more than just a couple of years. The Webbers' felt that Dennis earned that kind of honors for all the years that he has put into the stock show. They would like the sign to remain on the barn.

Council Member Laramie Morgan stated that everyone appreciated how much Dennis has done. There was a

committee when we were discussing rebuilding the barn and the name Ferron Agricultural Center was determined at that time. Possibly the "Dennis Worwood Show Ring" and the sign could be used there. The sign was taken down and given to Dennis to have so mainly it did not get crushed. The name of the building will be the "Ferron City Agricultural Center". It is not a stock show barn anymore. This is an indoor arena now. It will be totally different that what we had. We could possibly look into naming the show ring or something like that after Dennis and use that sign. It would be great to acknowledge his name somewhere.




