Ferron City Hall has received numerous complaints concerning vehicles being parked on the roadway. Also, complaints about vehicles being parked on the walking pathway on Canyon Road. Please be advised that Ferron City does have Ordinance: 6-1-4:D.7

Time Limit; Impoundment: It shall be an infraction, subject to penalty as provided in section 1-4-

1 of this Code, for any person to park or leave standing on any public road, street, alley or City

property any motor vehicle for forty-eight (48) or more consecutive hours, and any vehicle so

parked or left standing may be impounded or removed by the Emery County Sheriff. For

purposes of impoundment and removal, the Emery County Sheriff may impound and remove

any motor vehicle which reasonably appears to have remained unmoved for forty-eight (48)

consecutive hours. The cost of impoundment and removal shall be charged to the owner or any

person who claims the impounded motor vehicle. (1979 Code § 11-344; amd. 1998 Code)

# **BURN WINDOW**

The burn window is now open from September 15<sup>th</sup>- MAY 31<sup>ST.</sup>

Please remember to get a burn permit before burning. You can receive a permit by going to the city website. www.ferroncity.org

It will link you to the Utah Air Quality web page where you fill out the permit. If you are unable to do the permit on your own, please come in or call the city hall and we will be happy to help you. It is important that you have a permit. If you do not have one and your fire gets away from you, you may be responsible for any cost incurred in fighting the fire.
