This request seeks to secure the expertise of experienced tree service providers to address trees which pose a hazard to vehicles or impair visibility of drivers.

Scope of Work

Contractors are expected to provide all equipment, labor, materials, and supervision necessary to complete the following tasks:

- Conduct a site evaluation in consultation with city representatives to assess the scope and priority
 of work.
- Trim trees in a safe and orderly manner.
- Remove dead, dying, diseased, or structurally unsound trees, ensuring minimal impact to surrounding property and vegetation.
- Dispose of all wood, brush, and debris off-site.
- Maintain clear communication with city officials regarding scheduling, progress, and unforeseen circumstances.
- Complete all trimming and removal by April 1, 2026

Bid Submission Requirements

Interested parties must submit a comprehensive bid package, which shall include:

- A comprehensive bid.
- Date of availability to begin project.
- Detailed pricing schedule, including unit costs for trimming, removal, and emergency services.
- Proof of compliance with all applicable local, state, and federal regulations.

Site Visit and Questions

All interested bidders are required to attend a site visit on September 23, 2025 at 9:00 AM. Site visit will begin at City Hall.

Contract Terms and Conditions

The selected contractor will enter into a formal agreement with Ferron City, stipulating the Payment terms tied to the completion and acceptance of work milestones.

Submission Instructions

Bids must be sealed and clearly marked "Tree Trimming and Removal Bid – Ferron City" on the envelope. Completed bid packages must be delivered to the Ferron City Office at 20 East Main Street by September 30, 2025, 5:00 p.m. Late submissions will not be considered. Electronic submissions may be accepted at the City's discretion—please inquire with the City Recorder.

- All bids become the property of Ferron City upon submission and will not be returned.
- The City reserves the right to reject any or all bids, to waive minor informalities, and to negotiate with the lowest responsive bidder as permitted by law.

Additional Information

All work performed under this contract must comply with applicable municipal codes, state statutes, and environmental regulations. Ferron City expects contractors to always adhere to industry's best practices.
