



## ORDINANCE NO. 19-002

### **AN ORDINANCE AMENDING THE FISCAL YEAR 2019 BUDGET OF FUNDS AND ACCOUNTS ENDING JUNE 30, 2019 FOR THE TOWN OF BRIAN HEAD, UTAH.**

**WHEREAS**, in accordance with the Uniform Fiscal Procedures Act for Utah Towns, Brian Head Town, Utah, has amended its budget for the fiscal year ending June 30, 2019; and

**WHEREAS**, in accordance with Utah State law, a public hearing was held on January 15, 2019 on the amended budget and comments received relating thereto, and;

**WHEREAS**, the Town Council determined an adjustment was needed for the purpose of unforeseen expenditures that have taken place since the adoption of the fiscal year 2019 town budget, and;

**NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF BRIAN HEAD, STATE OF UTAH:**

**ADOPTION:** The Fiscal Year 2019 budget hereby be amended, including all funds and accounts as follows:

**GENERAL FUND (10):** General Ledger 3890 – Fund Balance Appropriated will be increased from \$283,273 to \$326,525 and General Ledger 4410.253 – Streets – Snow Removal will be increased from \$30,000 to \$73,252.

**ASSET REPLACEMENT FUND (47):** General Ledger #4890 Budgeted Increase in Fund Balance will be decreased from \$107,771 to \$102,535; and General Ledger #4220.740– Equipment Replacement (Public Safety/Fire) will be created for \$5,236.

**SOLID WASTE FUND (53):** General Ledger 4753.111 – Overtime Wages (Sanitation) will be increased from \$2,000 to \$4,500.


Also, a transfer of \$25,000 will be made from the **Capital Projects Fund** - General Ledger #4100.720 – Capital Project – Town Hall to the **Asset Replacement Fund** - General Ledger #4100.720 – Town Hall (Fuel Tank Replacement).


