ORDINANCE NO. 19-013

AN ORDINANCE ESTABLISHING THE NAME OF FOX RUN FOR A CONNECTOR ROAD BETWEEN FOREST DRIVE AND FALCON COURT LOCATED IN THE CEDAR BREAKS MOUNTAIN ESTATES, UNIT A SUBDIVISION.

WHEREAS, the Town received a request for a road name change for a connector road between Forest Drive and Falcon Court located in the Cedar Breaks Mountain Estates, Unit A Subdivision to be named Fox Run, and;

WHEREAS, the Town believed it was in its best interest not to proceed with a formal final plat amendment due to costs associated with the process, but to confirm with the Iron County Recorder that the Town has the option to name a town road without having to have it officially recorded in the Iron County Recorder's office, and;

WHEREAS, the Town Council held a public hearing on October 28, 2019 to receive public comment on the proposed road name change to Fox Drive, and;

WHEREAS, the entire road is located within the Brian Head Town boundaries and is within Brian Head Town jurisdiction to change the name of its roads; and

WHEREAS, in making its review the Town Council finds that it is in the best interests of the health, safety, and welfare of the Town and its citizens to grant the requested road name to Fox Run;

NOW, THEREFORE, BE IT ORDINATED BY THE TOWN COUNCIL OF THE TOWN OF BRIAN HEAD, UTAH.

SECTION I: The connector road located in the Cedar Breaks Mountain Estates, Unit A Subdivision between Forest Drive and Falcon Court is hereby established as Fox Run identified in attachment "A"

SECTION II: The Town Council hereby directs the Town Clerk to post notice of the road name change within the Town.


EFFECTIVE DATE: The ordinance shall go into effect immediately upon final passage as noted below.


