4. Other Business

- A. Kalie Ward Garfield County Fair: Kalie Ward USU Extension office. She would like to see involvement with the County Fair will all communities. She would like to have a name and contact from the City to be on the fair committee. They will reimburse for mileage and feed you dinner. Deanna Moore asked to be the representative from Bryce City. She is a little overwhelmed with Ruby's right now, but will work in in. One goals for fair this year is don't sign your life away, volunteer for a year or two. Deanna would like to see more 4H programs in the County. Kalie is on that committee too. Anything USU can do for the City? Kalie specializes in family preparedness, family resources, and 4-H..
- **B. Panguitch Main Street Committee:** Sydnee Mecham is present asking for sponsorship for the Balloon Festival, which will be held June 21-24<sup>th</sup>, 2018. We have been a major even sponsor the past few years. She will email the form to us if we want to sponsor again this year. Last year we did the Major Event Sponsor \$1500.00, which includes advertisements with radio, website link to Bryce City, a balloon ride for 2, t-shirts, and dinner tickets with balloon pilots. Motion made by Mike to donate \$1500, 2<sup>nd</sup> by Bryce, Gary yes, Nick yes. Asked about Sydnee's opinion on our balloon glows, she doesn't feel like it is an issue at all. Lori Talbot- City Manager may have spoken with some of the pilots this winter trying to cause some problems. Sydnee feels supportive of our balloon glows. Last year balloon rally had fewer numbers due to the Brian Head fires.
- **C.** Bryce Syrett Building Permit: The permit includes an addition to current house bedroom and remodel. Motion to approve the permit made by Mike, 2<sup>nd</sup> by Nick, Gary Yes, Bryce Abstain.
- **D. Shuttle Parking Expansion:** Superintendent asked Shiloh about gravel pad next to Shuttle Building. She would like to see if Ruby's can clear it out for additional parking. Maybe add this to our 5-year plan for future growth to have it paved.
- E. Bryce Valley Sidewalk/Cross Walk along 500 West Donation: Shiloh sent out the email from Tropic Town, asking for donations for sidewalk for the Bryce Valley School students that walk from the high school to the Seminary Building to keep kids out of the construction zone while the new elementary school is built. Estimated cost will be \$10,000. Would like to see the numbers from the other communities? How much are they contributing? Will it be used after the construction is complete? Mayor Brinkerhoff is going to the County and asking for funds as well. There is currently safety with the children crossing without a cross walk right now. The School District needs to help keep the kids safe there. Table this discussion until next meeting and see what the County and other communities will contribute. Who will clean the sidewalks when it snows? The children walk the roads when they aren't cleared, will this sidewalk help?
- **F. Approval of Sheriff Office Contract services for 2018:** Gary makes a motion to approve the Sheriff's Office Contract services for 2108, 2<sup>nd</sup> by Mike, Nick yes, Bryce Yes
- **G. Canyon 2 Canyon:** Will be held Aug 25<sup>th</sup>. Deanna met with fly-in committee. Recommend starting earlier in the morning, maybe 7-ish and would like it to end earlier to get people down to the Fly-In. The Fly-In will start at 11 AM. Maybe move food Vendors at the Fly-In. Have a last shuttle time to Inspiration Point. We won't do a poker run this year,

Do we do the glow at the shuttle parking lot or move to by highway OBT. Council would like to keep the balloon glow by shuttle parking lot and do the Show and Shine next to it. County Fair will be Aug 16-18<sup>th</sup> this year. Deanna will send flyer with Fly-In and Canyon 2 Canyon home with school kids again. We will have advertisement on the billboard with the Fly-In. Will use same Canyon 2 Canyon logo from last year. Wyatt Moore can work on some advertisements. Council okay to keep using Wyatt. Would like to use the Jail Ink for T-shirts. Jail Ink can only use 5 colors. Original logo used 6 colors. Shuttle started at 8:30 AM last year and went until noon. Need to start shuttles by 7-7:30 in the morning and end earlier, maybe around 10:00 AM. The race sign up times will be online so they know when to arrive. National Park was concerned with congestion so need to stagger the riders. Deanna will start working on the permit with Bryce, and she will get the committee together. Decided to do 8:00-10:00 AM shuttles to Inspiration. Glow will be 8:30-9:30 PM.

H. Maria Montessori Academy Jr. High Student - Bryce Butterfield project: Deanna received an email from Bryce Butterfield, and is creating a presentation on Bryce Canyon.
