4. Other Business:

- **A. Law Enforcement Contract with Garfield County:** Council agrees to continue the contract. There are more people on the roads now. Motion to approve made by Nick, 2nd by Bryce, Gary Yes, Cherrie Yes, Mike Yes. Shiloh will reach out to Danny Perkins.
- **B. COVID 19 Updates:** Still here, however we are Yellow now. No new updates. Go ahead and remove from agenda.
- **C. 2020 Census:** They dropped packets off on some doors. It is easier to do online. Bryce Canyon City still says 0% completed so Shiloh reached out to Jerry Taylor to see why nothing is being reported. - **D. Isaac/Draysen- Wrestling Mat**: Asking for funds for a mat for the Wellness Center to train for a wrestling matches. The cost would be around \$802.00 -\$1000 for a 12 x 12-foot mat. The mat folds up and can be stored. Will fit in the storage room with the Dr. Dish. It can also be used for Yoga or different sports. Will put on next agenda for official vote. They will get the information to Taryn to order the mat. If any other wrestlers are around invite them to use it to practice on.

- 1. Roads: Jean did we decide to paint lines this year? It usually costs around \$7-8,000. Jean will contact Straight Stripe and get a bid and find out when it can be scheduled. Need to have someone go with them so they don't miss any areas that we have added on. Jean will follow up on it. Shuttle parking lot may be okay. Shiloh can drive around with them if needed. Section by the rodeo is getting bad, maybe look at fixing it soon. Bryce can have someone look at that portion of the road and get a bid on it.

- a. Restroom/Pavilion Facilities: Found the key, Taryn will get the bathroom open. The water is turned on. Basketball baskets have been lowered, we have the tool to higher them. Just watch kids so they don't hang on them.

- **4. Shuttle Building:** Tile in storage room is complete and Karl submitted the bill. The sinks need repairs and Taryn is working on with them. They are looking to open the shuttle by the end of the Month. Due to COVID they want fans running 24/7 in building, so we will wire the light switch to stay on 24/7.
- **5. Public Safety Building:** Garkane called and claimed we never paid bill on park restrooms and \$903.00 was added to our current bill. Shiloh found bills that we did pay monthly on the restrooms. Main street meters were over paid they should have been billed as low usage meters. Wellness Center billing \$38/month so not sure how it is being billed. Public Safety building around \$600/month. Garkane is finding meters all over they haven't billed for. We should

for the Shuttle Building meter.

- **7. Bike Path:** A lot of people on bike path. Path is looking good. Ruby's Ice Rink was not successful. They had the application reviewed by three judges. The first judge gave 25/25 and raved about the ice rink project, the 3rd judge gave a 24/25 and also raved about the project, however the 2nd judge gave 0/25 and stated it was just a way for Ruby's to make money. Lance has been in contact with legislation regarding the 0/25 application. Lance has been contacted and they are not sure why it was treated this way. Governor's office looking at it. The results came in the end of last week. Jean will have lance send out the letter to everyone to read it. Garfiled County applied for the outdoor recreation grant to repair the bike path. We will follow up with County to see if they were successful. Jean will follow up with Kaden Figgins. The Outdoor Grant funding did have \$7 million more in requests then they had money, so many projects were rejected.
- **a.** Canyon2Canyon Still planning on having it. Move forward and just not shuttle people. Jorgensen's had their annual ride last weekend and they had 35 people this year it worked good. Bike path needs to be patched was the only complaint.
- 8. Wellness Center: Going good since we opened longer hours. Taryn making sure they are signing symptom sheets. We are getting a few new sign ups. Tropic Town came and looked at the Wellness Center. They are working on a senior center/wellness center. Taryn has symptom forms printed off and they are available at the weight room. They are leaving it on the desk. They need to bring their own form, don't leave it and don't use a community pen. The foggers are on order but not here yet. Sysco is supposed to deliver sanitation wipes. Weight room is being wiped down good. Need to work on finishing fence. It will only take a few hours. Will meet on Tuesday morning to finish it.
- **a. Weight Room-** The bids for the old equipment have been posted in paper. Taryn has emailed some contacts that may not read the paper. He has reached out to Rawley at the Sheriff's office. Maybe reach out to school district. Deanna will forward email to Panguitch City. Taryn has not received any bids yet. June 4th is when the bidding closes. Braxtyn sent to Millard County they have expressed some interest.
