C. Jean Seiler – Advertising: Jean has received ideas for billboard advertisement. Did add visitbrycecanyoncity.com to new proposed billboard. Shiloh followed up with David Church on the arrangement and things are good. The City will pay for the vinyl and installation and Ruby's will continue to pay the lease on the billboards. One will be out by Bear Valley junction, and one near Red Canyon. Proceed with #4-blue print. Estimated cost will be \$1000/ per billboard. D. Day Care – Needed in the area. Is there any option to use Public Safety building or other buildings in the area? Can municipalities offer those services? Not recommended to use Public Safety building. Need to follow up on regulations. Buildings would cost \$150-\$200,000 to build. Jean can follow up on regulations. Better option to have someone operate out of a personal home.

Ron recommended keeping the fire work restrictions we have in place right now. Campground is strict on their fire areas currently. Ruby's burn pits shouldn't be an issue. Campfires in approved areas only. Leave all the other stage one restrictions. Motion made by Gary to follow Ron's recommendations, 2nd by Nick, Bryce yes
