A. Capital Improvements

1. Roads:

a. Main Street- Sealing has started. Working with Ruby's on the blocked areas. Sealing can be walked on once dried. Should take just a few hours. Yesterday's schedule (July 19th) will be done Sunday due to rain. Shiloh is getting speed signs back. Will have repair bill for one of the signs. All street signs need to be put up once they are knocked down. Keep watch of places that need them.

2. Town Park: Restrooms are being checked, need to stock toilet paper. Andy is checking them. May need to order larger toilet paper dispensers. Nick working on tables, we need to set up an account or prepay. He is ordering garbage cans and grills too. Approximately \$6,000 for all.

4. Shuttle Building: Brian emailed Shiloh and Gary, a girl hit her head falling off one of the benches. Brian wants to order some safety signs to place by the benches.
