**A RESOLUTION CANCELLING THE NOVEMBER 2021  
LOCAL ELECTION**

**WHEREAS**, all three municipal officers are elected in an at-large election;

**WHEREAS**, the number of municipal officer candidates, including any eligible write-in candidates (which needed to file at least 45 days before the election) for the at-large municipal offices does not exceed the number of open at-large municipal offices for which the candidates have filed;

**WHEREAS**, there are no other municipal ballot propositions;

**NOW THEREFORE**, it is hereby resolved by Bryce Canyon City that the November 2021 election is cancelled under UCA§20A-1-206, and that those filing for the said offices shall be declared to be elected.

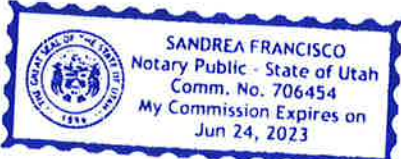
