RE: Request to Vacate Rear (East) Public Utility/Irrigation Easement at 1834 N 685 West


The Rosal's wish to build a shed in the northeast corner of their property at 1834 N 685 W but there is a conflict with the public utility/irrigation easement along the rear property line. They are requesting to vacate the ten-foot easement.

At the time Birnam Woods-Phase 2 subdivision was developed, the rear irrigation easement was planned to be abandoned by Weber Basin. Weber has confirmed their facilities have been removed and all other utilities have agreed to release the easement.

The process outlined in state code to vacate easements requires the city council to hold a public hearing which includes providing notice prior to the hearing in a local newspaper, to affected entities, posting on city and state websites, and posting a notice on the property.

Public notice has been completed, a hearing scheduled for August 18, 2020, and the property owner has provided copies of written confirmation from all major utility companies that they have no buried utilities in the easement and do not object to its release.

Staff does not foresee any negative impacts to the city by vacating the requested portion of this easement and recommends that Ordinance 432-20 be adopted.

# RE: Request to Vacate the East Public Utility Easement and Reduce the North Public Utility/Drainage Easement at 862 W Heritage Pointe Circle

The Heller's wish to build a garage in the northeast corner of their property at 862 W Heritage Pointe Circle but there is a conflict with the public utility/drainage easements along the east and north property lines.

Staff has reviewed the request and does not object to the release of the east easement but prefers a portion of the north easement to be left intact as it is intended to handle surface drainage for upstream properties.

The process outlined in state code to vacate easements requires the city council to hold a public hearing which includes providing notice prior to the hearing in a local newspaper, to affected entities, posting on city and state websites, and posting a notice on the property.

Public notice has been completed, a hearing scheduled for August 18, 2020, and the property owner has provided copies of written confirmation from all major utility companies that they have no buried utilities in the easement and do not object to its release.

Staff does not foresee any negative impacts to the city by vacating the requested portions of these easements and recommends that Ordinance 433-20 be adopted.



RE: Change Order to Holbrook Asphalt for 2020 Seal Coat Project

In this memo staff recommends approving a change order for \$27,299 for the 2020 Seal Coat Project to Holbrook Asphalt to provide a high-density mineral bond sealer.

### **Background**

The council previously approved a contract for \$117,838 for the purchase and application of a highdensity mineral bond (HDMA) on newly laid asphalt. It was staff's estimate at the time that approximately \$50,000 that amount would be paid by developers leaving the City's portion at \$67,838.

### Change Order

Shortly after the award was made, the contractor notified the city that the unit amount listed in the city's paperwork did not match the mapped areas also provided by the city. Staff had miscalculated the square yardage in some of the subdivisions. Additionally, public works staff has now also recommended expanding the areas to include a portion of 1100 W and Porter Lane.

Of the \$27,299.00 in the attached change order, approximately \$20,915 will be covered by developers and \$6,385 will be covered by the city. In total, developers will now cover \$69,200 and the city will cover \$75,800.
