**Quilt Categories** *Quilt must consist of three layers, with stitching through all three layers and stitching visible on both sides.*

**Large Quilt** Perimeter 288" or more, no more than 90" per side.

**Intermediate Quilt** Perimeter greater than 181" but less than 288".

**Small Quilt** Perimeter less than 181".

**Appliqué Quilt** Perimeter greater than 181" and 50% appliqué.

**Pandemic Projects** Must have been completed since March 2020

**Large UFO Quilt** Perimeter 288" or more, no more than 90" per side.

**Intermediate UFO Quilt** Perimeter greater than 181" but less than 288".

**Small UFO Quilt** Perimeter less than 181".

**Large Art Quilt, Representational (Pictorial)** Perimeter greater than 181". *Design must be original. No published patterns.*

**Small Art Quilt, Representational (Pictorial)** Perimeter less than 181".

**Art Quilt, Non-Representational** Original quilt without a recognizable or identifiable subject. Entries should extend beyond the traditional and innovative disciplines, using personal expression and originality in concept, design and execution. *Design must be original, one-of-a-kind*

Quilts must have been completed after January 1, 2018, and be in excellent condition, clean and free of odor and pet hair. Maximum of two judged quilt entries, no limit on pandemic quilts. **Quilts must have a 4" sleeve securely attached for hanging.** No rigid frames, glass or special hanging devices permitted. Quilts must be able to be folded. Rolled quilts require an extra \$5 handling fee. One quilt per entry form. **Limit of two quilts per entrant.** Notifications of acceptance will be emailed by August 25, 2021. Accepted quilts must be received by September 5, 2021 by dropping off or mailing them to Tami's address above. Quilts will be returned by October 8, 2021. **Quilts are not available for pick-up at the show.** Pick-up information will be provided in quilt acceptance letter. If you would like us to ship your quilt to you, please include a \$5 handling fee and enclose a prepaid shipping label to attach to your box. Promotional photography and use of the photographs at the discretion of Northwest Quilting Expo is permitted. There is no restriction of photography by individuals for their own enjoyment.
