

ORDINANCE NO. 2018-02

AN ORDINANCE ADOPTING SELECTED PROVISIONS OF THE WASHINGTON
COUNTY CRIMINAL CODE

RECITALS AND LEGISLATIVE FINDINGS

WHEREAS, the Town of Apple Valley is in need of a criminal code in order to provide for the uniform enforcement of violations of local ordinances;

WHEREAS, due, in part, to the Washington County Sheriff's Office acting as the Town's law enforcement authority, it is in the best interest of the Town to adopt the below listed sections of the Washington County Code as the Town's criminal code; and

WHEREAS, this Ordinance was considered in one or more properly advertised public meetings and has been available on the town website for public comment.

WHEREAS, this Ordinance supersedes and repeals all prior ordinances, resolutions, policies, and actions of the Apple Valley town council to the extent they conflict with this ordinance. Specifically, the following ordinances are repealed:

ADOPTION OF CRIMINAL CODE

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF APPLE VALLEY, WASHINGTON COUNTY, UTAH, that Apple Valley Town adopts the following sections of the Washington County Code, as amended, as the Town's criminal code:

Title 1-3-1 thru -3 (Definitions);

Title 1-4-1 and -2 (General Penalty);

Title 4-1-1 thru -3 (Nuisances);

Title 5-3A thru -3C (Animal Control)

Title 7-1 (Encroachments and Utility Construction); and

Title 9-1-1, -5 thru -9, -13 and -14 (Buildings, Land and Construction Codes and Regulations).

EFFECTIVE DATE

This ordinance shall take effect upon adoption and posting. Following its passage, but prior to the effective date, a copy of the ordinance shall be deposited with the Town Clerk-Recorder and a short summary of the ordinance shall be published in a newspaper of general circulation within the Town.


