- PAYMENT:** The applicant agrees to pay monthly for the services rendered.
- DELINQUENCY:** Payment for services is due at the end of the month and shall be considered delinquent if not paid by the due date. A monthly late charge of 5% of the balance will be added to delinquent accounts for each month that an account remains delinquent. The applicant agrees to pay reasonable expenses of collection, including attorney fees and court costs, should it become necessary to use such measures to collect the charges made to the applicant's account. All payments received will be applied first to the payment of late charges/administration fees and then to the principal amount due. Billing may be protested in writing or by calling office within 15 days of the postmark date.
- SECURITY DEPOSIT:** The applicant is required to pay a deposit in the amount set by resolution of the District. The deposit may be waived for customers who have established good credit with the District and/or the Town of Apple Valley. It is further understood that the District shall not be required to pay interest on any security deposit. Unpaid accounts will be considered delinquent notwithstanding the existence of a security deposit. The District may apply the amount of the security deposit to the customer's final bill and any credit remaining will be refunded. Customers who establish one year of good credit may request that their security deposit be credited to the account.
- REASONABLE ACCESS:** The applicant shall permit the District's authorized representatives to enter the property at all reasonable times for purposes connected with rendering or billing of the above referenced services. Customers shall not construct, erect, or otherwise put in place any barrier impeding free and easy access to all utility service meters.
- POLICY AND PROCEDURES MANUAL:** Applicant acknowledges policy and procedures manual is available on the Town of Apple Valley website or may be requested in person and must be read.
