### 2. Acknowledgment of Risks

I, the undersigned parent or legal guardian, hereby acknowledge that my child's participation in sewing classes, workshops, and related activities involves inherent risks. I understand that sewing involves the use of potentially hazardous tools and equipment, including but not limited to:

- Sewing machines, embroidery machines, and sergers.
- Sharp objects such as needles, pins, fabric shears, rotary cutters, and seam rippers.
- High-temperature tools such as irons and hot glue guns.

I recognize that these risks include, but are not limited to, minor injuries such as pinpricks, cuts, scratches, scrapes, and minor burns, as well as the potential for more significant injuries. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury that may be sustained by my child as a result of participating in these activities.

### 3. Medical Authorization and Consent

#### 4. Liability Release and Indemnity Agreement

IN CONSIDERATION FOR PERMITTING MY CHILD TO PARTICIPATE IN THE SEWING CLASSES, I, FOR MYSELF, MY CHILD, AND OUR HEIRS, EXECUTORS, AND ASSIGNS, HEREBY EXPRESSLY AND VOLUNTARILY RELEASE, WAIVE, DISCHARGE, AND HOLD HARMLESS NOT YOUR MAMA'S QUILT STORE, ITS OWNERS, OFFICERS, EMPLOYEES, VOLUNTEERS, AND AGENTS (COLLECTIVELY, THE "RELEASED PARTIES") FROM ANY AND ALL LIABILITY, CLAIMS, DEMANDS, OR CAUSES OF ACTION ARISING OUT OF NEGLIGENCE, PROPERTY DAMAGE, OR PERSONAL INJURY SUSTAINED BY MY CHILD WHILE PARTICIPATING IN THE CLASSES, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE.

*I expressly agree that this release and waiver is intended to be as broad and inclusive as permitted by the laws of the State of Texas.*

#### 5. Rules, Behavior, and Safety Guidelines

I agree that my child must strictly follow all safety rules, verbal instructions, and guidelines provided by the instructors.

- **Safety Equipment:** Children will be instructed on how to safely operate machines and irons.
