I hereby apply to Coalville City for permission to connect my premises with the Coalville City Secondary Irrigation Water System and hereby agree as follows:

1. The City shall make the requested connection from its water main to my property line. I agree to pay the City the hook-up charges and all user fees imposed by the Coalville City Council. The location of the connection to the City system, whether on my premises or at some point near my premises, shall be decided solely by Coalville City.
2. The cost of extending the water line lateral from the point at which Coalville City installs the connection to its system, to the place at which the water is to be used on my property, shall be my responsibility and shall be performed at my sole cost.
3. I understand that Coalville City reserves the right to inspect both the Irrigation/Secondary and Culinary Water Systems upon my premises as Coalville City determines is necessary and that if either or both systems are not in the condition required by Coalville City, it shall be my responsibility to cause the same to be corrected at my own expense to meet the requirements of Coalville City.
4. I will be bound by the rules, regulations, resolutions and ordinances now in effect or hereafter adopted by Coalville City pertaining both to the Culinary as well as the Irrigation/Secondary Water Systems, including those for the payment of user fees, charges, penalties and cost of collection, including attorney's fees and related fees, all of which I agree to pay upon demand.
5. The Irrigation/Secondary Water connection shall be used for the irrigation of gardens, lawns, trees, shrubbery and plants.
6. Coalville City shall have free access to my property during ordinary business hours, or in the event of an emergency at any time, for the purpose of inspection to the lines, risers and services installed on my property.
7. In the event of my failure to pay any rates or charges as billed by Coalville City for water service for Culinary and/or Irrigation/Secondary water, Coalville City shall have the right to shut off all water service, both Culinary and Irrigation/Secondary. Service may be discontinued in the sole discretion of Coalville City until all delinquencies, penalties, reconnection fees and a deposit are paid in full.
