3. Revisit St. Paul Lutheran Church Monthly Rental

Chairperson Schoepf-Pearce apologized and stated the issues should not have been handled so quickly. Further discussion with Jackie Wagner, from St. Paul, was done by Secretary/Treasurer Gonzalez and Chairperson Schoepf-Pearce. Jackie Wagner from St. Paul had told Gonzalez and Schoepf-Pearce the gym would be able to be used 8 – 10 times a month. Gonzalez stated this was different than the 10 – 14 events that were presented at the previous meeting. Gonzalez also pointed out that this also did not include the lighthouse being rented. To rent the lighthouse for bingo would still be another \$100 for each use.

Gonzalez informed the board that Cornhole was not canceled because of the revisiting of using St. Paul, it was because it was only a 6-week league and six weeks had been completed and another 6 weeks had not been voted on.

Chairperson Schoepf-Pearce discussed with board members about the usage of USD 312 facilities and the meeting that was held between Superintendent Idacavage, Chairperson Schoepf-Pearce, and Secretary/Treasurer Gonzalez. A Memorandum of Understanding is to be drawn up between the City of Haven Recreation Department and USD 312 and a meeting to come to an agreement will be held.

Director Pace said she will try to have another meeting with Jackie Wagner from St. Paul for more clarification on details.
