2. Valentines Dance

accompanying them. Gonzalez will contact the school and request a call or email go out to remind parents it is a parent/child dance, and it is not school sponsored.
3. Job Roles

Member Bell inquired if there is a form that list employee duties. Bell continued to explain the request for this because of an incident that happened at a basketball game where the time keeper tried to kick out adults from the opposing team and the gym supervisor did not feel the actions that took place warranted an eviction. Director Pace stated that refs and score keepers have every right to kick anyone out and it is the job of the gym supervisor to back the timekeeper and refs. Member Thetford asked what the duties of the gym supervisor are, and Pace informed the Board the gym supervisor is there to open the gym or facility, check bathrooms, back the refs and timekeepers, and close the gym. Member Powers recommends job descriptions need to be created. Member Bell reminded the Board the reason why the employees do not keep track of their own timecards is because Director Pace stated they were not responsible enough and if they aren't mature enough to keep track of their own timecards then they shouldn't have authority to kick people out. Member Tate feels that refs have authority, but timekeepers should have to go to the supervisor. Director Pace will have job descriptions created and sent to Secretary/Treasurer Gonzalez to be distributed with the March board meeting packet.
4. T-Shirts

To help the public and participants of events know who the gym/field supervisor is, bright green $t$-shirts will be created for all board members to wear. Pace said her company would purchase the shirts and Member Thetford said she can make them.
5. Social Media and Media

Member Bell distributed a handout and went over post statistics and interaction with Haven Rec Facebook page. Bell reiterated it was agreed upon in previous meetings that she would be the primary controller of the Facebook and social media sites. Any photos to be posted need to go to Member Bell first. The meeting resumed to discuss calculate the difference between the current wages and the proposed wages. At 8:08 PM Vice-chairperson Tate then moved the Recreation Board to recess into executive session to discuss personnel matters relating to non-elected personnel, the Recreation Director and Secretary/Treasurer, the open meeting to resume at 8:10 PM in the Community Building.

At 8:10 PM the regular session resumed.
ACTION: Member Dalke motions to approve Recreation Director wage to $\$ 12,000$ a year and the Secretary/Treasurer wage to $\$ 2,400$ a year with retroactive pay starting January 1, 2023.
