

# REFUSE & RECYCLING

All trash should be placed in the green cart, which is emptied each Tuesday between 6am and 5pm. Please be sure to remove your cart from the curb by 6pm that day.

Recyclable items should be placed in the tan cart, which is emptied every *other* Tuesday between 6am and 5pm. You are not required to recycle, but there is no reduction in price for opting out.

**Do not place the following items in your carts: automobile batteries, household hazardous wastes (chemicals, paint, cleaners, insecticides, herbicides, etc.) or hot, explosive, or corrosive materials, used motor oil, or any other liquids. We also cannot accept any appliance containing or previously containing refrigerant (freezer, refrigerator, air conditioning unit). Also, please do not allow children to play with or in the carts.**

**Do not bag your recyclable items. Also, do not include these items in the tan recycle cart: aerosol cans, Styrofoam, batteries, plastic bags, shredded paper, oil or paint cans, hazardous chemicals, ceramics, crystal, glass windows, mirrors, windshields.**

There's no extra charge for additional trash. Simply place it in throwaway containers beside your green cart. Or if you require disposal of a bulky item, contact the Office to arrange for a special pick-up.

The carts are extremely durable, designed to withstand extreme temperatures and use but do have a weight limit of 200 lbs. Carts that fail due to normal wear and tear will be repaired or replaced at City expense. Carts damaged due to overloading, loading of prohibited items, or other abuse will be repaired and replaced at the customer's expense. Replacement costs of lost or stolen Carts will be charged to the resident to whom they are assigned.

Carts should be placed at the curb and at least five feet away from any obstacle (including cars, mailboxes, other carts, etc.) because the collection truck utilizes a mechanical arm.

## TREES

## UTILITIES

The City supplies electricity, water, sewer, and disposal refuse service to all residents. Gas service is provided through Kansas Gas Service (800-794-4780). In order to open a utility account in your name, the City requires either a \$250 deposit or a letter of good credit from your previous electric utility service, indicating no more than one late charge in the last 12 months of service. Should you experience a break in service, call the City Office. For problems after hours, call 620-465-3619.

Additionally, a disposal refuse site is available for city residents to haul tree limbs and clean lumber only. This site is open each Wednesday and Saturday and is located 1/4 mile east of Haven Road on First Street. Call the Office for the site's hours.

## LIBRARY

The Haven Public Library has been recognized by the South Central Kansas Library System of Hutchinson as an outstanding small library. It is located at 121 N. Kansas Avenue. Hours are as follows:

Tues. & Thurs. 12—7pm

Wed. 12—5pm

Fri. & Sat. 9am—2pm

Closed Sunday and Monday.

## DOGS / PETS

All dogs must be licensed and vaccinated for rabies on a yearly basis. Yearly licenses are due in January of each year at a cost of \$5 for each dog. A charge of \$10 per month is added to the fee for each month that the license is not renewed. Residents failing to meet licensing requirements may be cited to Municipal Court. No licenses are required for cats; however, by ordinance, the City prohibits any other type of pet or exotic animal within the city limits.

## LAWN

All residents are encouraged to take pride in the appearance of their property. An ordinance prohibits residents from allowing weeds and grass to grow out of control in their yards; anyone cited for violations of the ordinance will be granted due process as specified.

## RECREATION
