## NOTICE OF PUBLIC HEARING

The Lindon City Planning Commission will hold a public hearing at 6:00 P.M. or as soon thereafter as possible, on Tuesday, May 25, 2021, in the Lindon City Center, 100 North State Street, Lindon, UT, to consider the following items:

A request to amend the Lindon City zoning map for the rear portion of the property located at approximately 850 W. 200 S. with Parcel Number 14:065:0158. The rear portion of the property is zoned Residential R1-20 and the proposal is to rezone the property to Light Industrial to construct 75 storage units. Application is Made by Lindon Self Storage.

A request to amend the Lindon City zoning map for the properties located at approximately 523 W. 400 S. with Parcel Numbers 40:283:0007 and 17:015:0121. The proposal is to amend the current zoning from Planned Commercial 1 (PC-1) and Research and Business (RB) to Mixed Commercial. Application is made by Kent Nitta. The planning commission encourages the public take appropriate Covid-19 precautions. The Planning Commission will make a recommendation on all public hearing items to the City Council.
