1. Preliminary city approved copy of 24"x36" plat and site plan for commercial. Some utilities will need paper copies; some will need an electronic copy.
2. Preliminary plat must show "city approved" lot numbers, street names, and addressing (critical for 911 services, billing process, and correct land base records).
3. Preliminary plats must show all "city approved" utility easements and dimensions.
4. Will need developer contact information.
5. Will need approximate construction start dates, install dates, and anticipated "ready for service dates".
